Mr. Speaker, following the approval of the budget estimates for the budget approval, the County Appropriation Bill has not been assented and hence this house has been authorized by the standing orders 214, to approve the estimates to be used. This house has been authorized to approve the use of the money to be used for the Samburu County to meet the expenditure for the services for the time if the Appropriation Act was not assented to.
