PRAYER

STATEMENTS

MCA Baawa ward, (hon. Pius Lobuk): Madam Speaker, hon. Leakono, the MCA for Elbarta, requested for a statement from the Implementation Committee which required a lot of information to be presented by the committee. The statement pertains to all the departmental annual reports for the last two financial years. I request for your indulgence pertaining to this statement. We have written to all departmental heads to furnish the house with this information and since we are anticipating that all the departments will adhere to this, we are yet to receive the information. I request to be given more time and I promise to present the report on Wednesday next week. Finally, this is a house committee and we have sectoral committees. I need your direction because, before this committee intervenes to present the financial reports for the last two years, in my understanding, it is the role of the sectoral committee to approach the respective heads of departments to present this report to the house. That is the situation as at now.

Temporary Speaker, (hon. Linda Naserian): Thank you hon. Members, I would wish to refer to Standing Order number 189 section (2) part (a) which states the roles of the Committee on Implementation. "The committee shall scrutinize the resolution of the county assembly including adopted committee reports, petitions and undertakings given by the county executive committee in examining whether or not such decisions or undertakings have been implemented and the extent to which they have been implemented and whether such implementations have taken place within the minimal time necessary". It was in order for the hon. Member to direct the statement to the Implementation Committee because they were to scrutinize whether the county executive members have actually implemented the various projects in the financial years. Since you have requested for more time, when do you think you can report to this hon. House?

MCA Baawa ward, (hon. Pius Lobuk): Madam Speaker, I requested until Wednesday next week because we need to give these people time to present this report.

Raisy Letura): Thank you Madam Speaker, I now report the progress of the Committee of the Whole House on the deliberations of the Samburu County Supplementary Appropriation Bill 2015. The committee has gone through the bill and I am happy to report that some of the amendments were introduced while some were typing errors. One of the amendments reported and agreed by the house was amendment on first schedule which is R4212 to R4221. As per the original bill that was tabled in this house, in all those parts, it was reading that the year was ending on 30th of June, 2015. But the financial year that the bill was supposed to refer to was to end in 2016. Hence the R4212 to R4221 was changed from reading the year ending 30th of June, 2015 to year ending 30th of June, 2016. The other amendment that was introduced by members was D4211 to D4221 that in all those parts, was reading year ending 30th June, 2015 and it was amended to read year ending 30th of June, 2016. The members unanimously agreed with the bill apart from those minimal amendments done which were resulting from typing errors. Thank you.
