**MCA Elbarta Ward,** (Hon. Romano Leakono): Thank you Hon. Speaker Sir. Pursuant to Standing Order number 41(2) c, I hereby request a statement from the Chairperson of sectorial Committee on Public Works, Water and Roads regarding the state of the roads in Elbarta Ward, street lighting in Baragoi town and the fate of the 19 MAWASCO employees. Public transport is a critical strategy imperative in the department service delivery agenda. The department is mandated to implement measures to ensure an effective, efficient, affordable a sensible public transport systems in both urban and rural areas through, among others the implementation of the integrated public transport networks and establishment and strengthening of regulatory entities opening new roads and development and upgrading of existing roads corridors. Further to this is that there have been regular requests to the department to open up rural roads in various parts of the County for efficient service delivery. In view of this the Chairperson should inquire into and report on.

- 1. The status of the new road in Elbarta Ward Teremuka road, Barsaloi to Masikita junction opening of the new road which is long overdue budgeted in the financial year 2014/2015.
- 2. The status of the street lighting having been projected in the budget the department should report on the progress of the tendering process.
- 3. The plight of the former BAWASCO who were not absorbed when 19 of them were transferred to SAWASCO. The question above has been referred to the department earlier this month. Having passed by a document around one person cannot take the place of 19 other people who were supposed to have been absorbed by SAWASCO too.
