MOTION

Hon. Speaker, I wish to move the following motion;

CONCERNED THAT, over the past decades, Archer's town has become recognized as one of the most entrepreneurial towns. It's strategically located being next to Isiolo International airport and futuristic resort city and being in the way of trans-African Highway. It is adorned by tourist destination sites like Samburu and Shaba National Wildlife Reserves, Namunyak, Kalama, Westgate Community Conservancies, Reteti Elephant Sanctuary, Sera Rhino Sanctuary and a dozen of five star hotels;

DESPITE Archer's being a home to Samburu Technical training college, several secondary schools, site for British Army Training Unit in Kenya (BATUK), and in spite of its potential, it has remained generally underfunded and undeveloped for lack of concern from the county government. The county government has done little to improve the road network, water provision, waste management and street lighting in order to sustain the fast growing population and urbanization. Archer's ought to be given a concern and priority in physical planning and beaconing in preparedness for the Lamu Port and Sounthern Sudan- Ethiopia Corridor (LAPSSET) Project;

AWARE THAT, Section 10 of the Urban Areas and Cities Act, 2011 (Revised) lays down criteria and eligibility for conferment of a town status to a market center;

FURTHER AWARE THAT, conferment of a town status will ease management of a town through a committee, create employment for the youth and justify for planning;

CONCERNED THAT, Archer's has met the following criteria;

- a) a population of at least two thousand residents according to the final gazetted results of the latest population census carried out by an institution authorized under any written law, preceding the grant;
- b) demonstrable economic, functional and financial viability;
- c) the existence of an integrated development plan in accordance with this Act;
- d) the capacity to effectively and efficiently deliver essential services to its residents as provided in the First Schedule; and
- e) Sufficient space for expansion.

NOW THEREFORE, This House urges the County Executive Member for Lands, Physical Planning, Housing and Urban Development that, upon this motion, considers Archer's for the conferment of town status, AND considers its physical planning & beaconing.
