**Honorable Speaker,**

For every financial year, county governments will be entitled to not less than fifteen per cent of all the revenue collected by the national government. It is the responsibility of the department of Finance, economic planning and Marketing to ensure that all loopholes in tax collection in the county are managed. It has been established that the revenue collected in the Samburu national reserve has been declining due to the inefficiency in revenue collection and also there are very many upcoming markets and even sand harvesting in samburu east sub-county and without enough revenue clerks the county government will lose a lot in terms of revenue.
