The County Assembly met at the County Assembly chambers at 2.30 p.m.

(The Speaker, County Assembly of Samburu (Mr. Steve Lelegwe) in the chair)

PRAYER

MCA Maralal ward, (hon. Elly Loldepe): Thank you hon. Speaker, I rise to table a report of financial statement for the year ended 30th June, 2015. I recommend it to the assembly for adoption pursuant to Standing Order number 180, thank you.

NOTICES OF MOTION

MCA Maralal ward, (hon. Elly Loldepe): Thank you hon. Speaker, pursuant to Standing Order number 44, I wish to give a notice of motion that this house debates and approves the report and financial statements for the financial year ended 30th June, 2015, thank you.

STATEMENTS

MCA Ndoto ward, (hon. Raisy Letura): Thank you Mr. Speaker, I wish to respond to a statement sought by hon. Leitore. The member requested for a statement on 30th July, 2015 from my committee pertaining the auctioning of a parcel of land known as LR number Samburu/Lodung'okwe/8, registered in the name of Job Moika Lalampaa. The committee conveyed the request for the statement to the County Executive Member in charge of Physical Planning, Housing and Urban Development. On behalf of the committee, I wish to report the communication received from the CEC. Among the questions sought included:

1. What plans does the Department of Land have to intervene on the said land issue between the AFC bank, Job Lalampaa and the community?

The answer to that is that Job Lalampaa is the registered owner of the disputed parcel and its title deed having acquired it following land adjudication procedures. The undertaking and transactions between AFC bank and Lalampaa was purely between a lending institution and its private customer. The defunct county council was not party or guarantor to the private transaction and therefore cannot intervene on the matter.

2. Could the county government consider buying this land both for its use and of that of the community as advised by AFC bank?

This is a matter that would require consultations between various departments for such a decision to be taken if deemed to be in the interest of the county.

3. Whether any amount was allocated in the budget to settle the AFC bank's defaulted amount to revert back the land.

The said loan was secured by a private individual on private terms and conditions and therefore the recovery of such an amount cannot be subjected to department's budgetary provisions unless by prior approval by the government through the County Assembly. Besides, the matter was never a subject of budgetary discussions in the 2015/16 financial year. I beg to lay the response, thank you.

MCA Suguta Marmar ward, (hon. Shadrack Lesoipa): Thank you Mr. Speaker Sir, hon. Letura requested for a statement on 15th September, 2015 from the Chair of the sectoral Committee on Education, Youth Affairs and Sports concerning the food rationing in Samburu ECD centres. The committee conveyed the request to the respective CEC member. On behalf of the committee, I wish to report the communication received from the CEC member... (Interrupted by a call for a point of order)

The Speaker, (Mr. Steve Lelegwe): Continue hon. Linda.

Special Elected MCA, (hon. Linda Naserian): Thank you Mr. Speaker, you have not ruled on the first statement which we need to deliberate to as a house before the response to the second statement is made.

The Speaker, (Mr. Steve Lelegwe): The chair thought there were no issues regarding the statement as I waited for a moment before giving the next statement to be responded to. If there are any issues regarding the report as tabled by hon. Letura, they can be raised after tabling of the response by hon. Chair of Education. Continue hon. Lesoipa.

MCA Suguta Marmar ward, (hon. Shadrack Lesoipa): Thank you Mr. Speaker Sir, On behalf of the committee, I wish to report the communication received from the CEC member. This pertains to the delivery of food rations to specified ECD centres in Ndoto ward. The department is concerned and informed of the above facts and has addressed the problem by sending officers to the ground with an intention to ensure that food stuffs are delivered to the nearest possible storage facilities in consideration to the valid challenges as contributed by the following:

- 1) There is poor road network/inaccessibility.
- 2) There is lack of storage facilities.
- 3) There is lack of employed personnel.
- 4) Teachers to be entrusted food stuff for proper management and accountability.
- 5) Some ECD centres are non-operational.
- 6) Some ECD centres are mobile and keep on shifting.

The affected ECD centres as per the request could be described as follows:

- 1) There is Ura ECD centre which is attached to Ura Primary School and they share the same compound. The centre is therefore not entitled to county food rations as it benefits from the World Food Program and the department has delivered their food stuff to a convenient storage and managed at Ura Primary.
- 2) There is Suran ECD centre. The centre has no road at all hence the transporters were forced to deliver their food stuff at Ura primary School.
- 3) There is Nonjura ECD centre. The centre is inaccessible due to very poor road network and the transporters and officers resolved to deliver food to the nearby Latakweny Primary School.

- 4) There is Keleswa ECD centre. It is attached to Keleswa Primary School and share the same compound. It benefits from the World Food Program and therefore not entitled to benefit from the county rations.
- 5) There is Kasipo ECD centre. The food rations were delivered at Seren Primary School where a big lorry track could reach. The department intends to transport the food stuff to beneficiary centres soonest possible.
- 6) There is Ndonyo-Uwas ECD centre which does not exist and had not been budgeted for.
- 7) There is Keno ECD centre which has no teacher and hence not functional. The department however, delivered the food stuff at Salato Primary School's store for safety as measures are put in place to ensure it is functional.
- 8) There is Maragi ECD. The food was delivered at Salato due to lack of trusted personnel i.e. the head teacher.
- 9) There is Siang'ang ECD. It has no storage forcing the transporter to deliver to Salato Primary School as the department work out modalities for delivery on availability of safety and proper management.

It is important to note that the county food rationing program falls under the normal category of government supplies which are subject to accountability and minimal exposure to unnecessary risks. The department has put in place food for use in administration and management of food rations to ensure transparency and accountability at the ECD centres level. Most of the ECD teachers have been found not capable of completing the relevant records leading to misuse of food stuff. The primary school head teachers have been playing an important role in coordinating programs from SFP to their satellite ECD centres. This office has therefore found the primary school stores as the most effective units for administration of the feeding program I areas such as those in question as the department continues to improve accessibility through the provision of storage facilities and posting of personnel among others. I beg to table the response, thank you.

MCA Ndoto ward, (hon. Raisy Letura): Thank you Mr. Speaker, I wish to thank the hon. Chair for Education, Youth Affairs and Sports committee for the timely response. However, he responded to the statement as if the same has been going on for the last 3 years that the county government has been in existence. It is true that the food stuff were delivered to the said primary schools. But it is the first time that the food was delivered to the mother primary schools. I accept that vehicles cannot access Suran but initially food was delivered at Lesirikan and not Ura Primary School. Same applies to ECDs like Kasipo and others. All food was delivered to Lesirikan Primary School. The communities were initially using donkeys to transport food from Lesrikan to Ampaa next to Ura, Suruan and Ndasati ECD. In Latakweny area, it is not true saying they cannot access Nonjura ECD centre and yet there is a road going to Nguronit. We even passed with the Chair on that road at some point in 2014 from Nguronit to Latakweny then to Maralal. The department should maintain what they have done this time. Last term the schools got food and the community appreciated and it was the first time since the conception of the county government. I gave an example of a school receiving 6 bags of cereals but the community

used one to pay the donkey drivers, another to pay the transporters and other charges. There were about 4 bags which were lost on the way. Among the ones that reached the school, there was a 90 kgs bag which got there with only 28 kgs and the school had to close indefinitely. If they maintain what they have done this time round, I don't mind the transportation because they had even used the police trucks to take the food to schools. The end justifies the means. What we want is for the schools to get food. If it is food for Ura it should reach to Ura Primary School. I have no problem food being stored and managed at Ura Primary School. On Keno ECD, I don't agree when they say that the school doesn't have trusted personnel. The department built an ECD centre and the Missionary, headed by father Juliani, built another class. The community utilizes one as a store and we have a very responsible committee there. Even though we don't have an ECD teacher now, we are hopefully going to get one but we need those kids to attend school because we have people keeping them busy. We understand the level of ECD as it is not just about reading and learning but about socialization. So they can even go there and make stories with their grannies. So we need that food to go to Keno and I must say there is a lot of improvement this time round. I received phone calls from my constituents appreciating the department. I received good food and even one ECD received 4 twenty litres jerricans of oil which will last the ECD till the end of the term. I congratulate the department but I ask them not to forget very first what they have done, thank you.

MCA Maralal ward, (hon. Elly Loldepe): Thank you hon. Speaker, I want to thank the Chair for the response. Although the hon. Member for Ndoto is satisfied, but the department still needs more answers. If you look at the first school, they said it could be described as Ura ECD centre which is attached to Ura Primary School and share the same compound. The centre is therefore not entitled to county food rations as they benefit from the World Food Program and the department has delivered their food stuff to a convenient storage and managed at Ura Primary. You say that the school is not supposed to benefit but you go ahead and give food to the same school. The Chair should tell us why so. Ura did benefit despite the fact that it is also benefiting from the World Food Program's ration. Keleswa ECD centre is attached to Keleswa Primary School and share the same compound. They benefit from the World Food Program rations and therefore not entitled to benefit from the county food rations. Therefore this centre did not benefit. Why the double standards? Most schools even in Maralal that have ECD centres within their compounds don't benefit. What is so special about Ura ECD that is benefiting from the World Food Program and also from the county government? This food could be sold in any way. When I was not in this county government, I saw people sell the World Food Program's food and put other foods in those bags for accountability purposes. So if you take food to a school that is benefitting from the World Food Program, mischiefs can come in. The chair should help us understand why the double stands. The Speaker (Mr. Steve Lelegwe): Member for Suguta Ward, continue Hon. Lentukunyei

The Speaker (Mr. Steve Lelegwe): Thank you Mr. Speaker, I also wish to ask if it is in order for the Hon. Member for Wamba West to refer to the two Hon. Members as close, we do not understand the context of their closeness to this Hon. House, they should apologize, thank you.

The Speaker (Mr. Steve Lelegwe): Thank you Hon. Members, as you continue to raise your point of orders by noting very small errors made by Hon. Members when they are tabling their responses on statements as tabled by Hon. Lesoipa, I wish that we do not distract the House orders as you know that we are all Hon. Members of this House and the closest colleague for Hon. Lesoipa is Hon. Leakono and Hon. Sophia not any other Member from the other sitting place of the County Assembly, continue Hon. Lentukunyei.

MCA Elbarta Ward (Hon. Romano Leakono): Point of information

The Speaker (Mr. Steve Lelegwe): Continue Hon. Leakono

MCA Elbarta Ward (Hon. Romano Leakono): Thank you Hon. Speaker Sir, I think that when the Hon. Member is addressing he should use the microphone on his left, thank you sir.

MCA Wamba North (Hon. Christopher Lentukunyei): Thank you Mr. Speaker, I wish to congratulate the Hon. Member for Suguta MarMar ward, who is also the Chair for Education from his efforts to give his response to the questions sought by Hon. Letura, regarding the issue of delivery of food to ECDs centers in his ward, and I only had to point it out few lame excuses that the Chair is giving to this house, which I wish to point out, according to the Member, the excuses that he is giving that I have noted in his statement that the problems that are hampering are different from delivering food to the designated area, first is the infrastructure, I think that the Hon. Member is misleading the House because I just want to point out specific areas the road network is in good condition, a road like Ndonyo Wasin, this is a very good road and Mr. Speaker, you know the distance between Ndonyo wasin and Martha Pareu is 50 kilometres, and the food intended to be taken to Marti epareu is left in Ndonyo wasin, people in Marti epareu are forced to hire donkeys to give that is equal to sell almost half of the food to pay the donkey transportation, can the Member explain further the reason why the people of marti e pareu are not receiving food from their area rather than leaving food in Ndonyo wasin, the Marti e pareu also happens to have storage facilities in their place because he also pointed the storage facilities as one of the things that is taking them to school, the Member also indicated it in his statement the storage facilities are not available in our ECD centers, even the storages food is still left in areas like main centers, he also said that the department has lease trust in giving responsibilities to ECD teachers to handle the food, how do they trust primary teachers rather than the ECD teachers whereby the ECD teachers were employed by the department and the primary teachers are employed by the National Government, in my view, the Member should revisit his statement and bring a comprehensive statement to this House, because the Member for Ndoto ward acknowledged that ECD centers received food according to their wishes, only after he complained in this House that ECD centers are not getting food, so it is becoming clear that services are always given depending on who shouts most in this House, (applause), so I request that the

department should give temporary measures on how this food should reach to the designated areas rather than waiting for storage facilities to be constructed which we do not know and we do not even believe that it will happen in the future, thank you Mr. Speaker.

MCA Wamba West (Hon. Benjamin Leitore): Thank you Mr. Speaker, I am also standing to contribute on the same because the pertaining issue number 630 Ndonyo Wasin ECD center as also said by Hon. Members who contributed before me, I do not know who is misleading the other or who is giving the wrong information, because I think that the Hon. Member for Ndoto, are also said some information in ECD centers, that is said in the response that it is not existing and that there is no center there, so I don't know how a Member could seek information on a center that is not existing, I think that the department should be serious here because we have more than 500 centers in this County used to exist even before the establishment of devolution, this centers were being run by communities under certain primary schools so Mr. Speaker I do not know who is giving you those grounds should the department say that this centers is not there while the Member representing the place has indicated that we want some information pertaining that area, the issue of food delivery is cross cutting, it is all over and we actually need to understand or the Chair to tell us exactly what mechanisms are in place or are they putting in place to make sure that this foods are delivered to right centers, under the management of the ECD teachers that we employed as a County Government of Samburu, because we cannot employ teachers that we do not have trust on, issue of delivery, issue of food disappearances especially in schools have always been there especially from time in memorial, even food that was supplied by the world food program have been disappearing at the end of each and every term there should be balances which do not end up not being taken to the ECD centers they get sold at primary schools, so there is an issue of food delivery and the issue of poor road networks should not be a reason because we are specific on a certain good roads that the department does not intend to use, so I opt to leave this roads at the closest primary school rather than delivering them at the right ECD centers, so we want to be told by the department what mechanisms are there to make sure that their food that we procure to the County Government to be delivered to the correct ECD centers

The Speaker (Mr. Steve Lelegwe): Hon. Chair for Education

MCA Suguta MarMar Ward (Hon. Shadrack Lesoipa): Thank you So much Mr. Speaker, I stand to respond to some of the queries as brought by the Hon. Members, first, I thank the Hon. Member for Wamba North for the great concern but I wish to tell the Hon. Member that I think he is out of order because I was entitled to respond to the statement by the Hon. Member for Ndoto, if the queries of Wamba North are the same please you know the procedures of the House, I will be able to respond for your queries, otherwise we give permanent solutions and not temporary to the problems affecting our people, let me proceed, for the questions

Point of order

The Speaker (Mr. Steve Lelegwe): Continue Hon. Leshoomo

MCA Lodokejek Ward (Hon. Jarias Leshoomo): Mr. Speaker I think that it is wrong for the Hon. Member to say that they give solutions to the queries asked correctly, as Hon. Members, Hon. Lentukunyei has a right to ask any question concerning ECD centers in Samburu County, we represent the people of Samburu County not in particular specific wards, I think that there is something that the Hon. Chair should clarify first before responding to queries that are necessary, like Hon. Loldepe asked queries on...

The Speaker (Mr. Steve Lelegwe): Order Hon. Leshoomo, you have raised your point of order and there is no more time for you to continue referring statements or contributions of other Members, continue Hon. Chair for Education with your responses

MCA Suguta MarMar Ward (Hon. Shadrack Lesoipa): Thank you Mr. Speaker; there is another issue that was raised by my good friend the Hon. Member for Maralal Ward, there is also an issue of trusting a teacher, you do not trust a teacher on food but you trust them with kids, I think this is an issue of misappropriation of food and I think that it is only an individual that probably has been entrusted with that food at any other time, but it was found out the he was not trusted anymore, he misappropriated his hand on that food for this small kids, and that is why a reason for temporary solutions are being solved, I think that is why the food is being taken to that place, and there Is also the issue of the two schools under the world food program, food was delivered to one and the other was not, we are still going to find out but I think that is an English error that occurred, otherwise I still have to and consult on more information

MCA Ndoto Ward (Hon. Raisy Letura): Point of information Mr. Speaker

The Speaker (Mr. Steve Lelegwe): Order Hon. Letura and I want to bring this to the attention of all Members that the statement of Hon. Letura Member for Ndoto Ward requested for a statement on the 15th September 2015 from the Chairperson of the sectorial committee on Education, Sports and Youth Affairs concerning food rationing of Samburu County ECD centers, and Hon. Lentukunyei is in order to clarify what measures the department is taking in rescuing the situation in other parts and not specificall Ndoto Ward, because as the statement before me is in concerning the food situation in Samburu ECD centers, so Hon. Lentukunyei is in order and I request the chair for Education to...I know that there are other questions that are specific but the Chair of Education had the responsibility to inform the House about the ECD centers of Samburu County, continue Hon. Chair and do not dispense the contributions of Hon. Members, continue.

MCA Suguta MarMar Ward (Hon. Shadrack Lesoipa): Thank you Mr. Speaker for your guidance and your wisdom but Mr. Speaker I am only saying that the height of comparison because the Hon. Member was comparing Ndonyo Wasin and Mart Eparaeu that he did not give to that statement to be able specifically to tackle that issue in Ndonyo wasin and Marti Epareu, and if this problems are there then we need to go and look at it, because that issue was not before the house so that I can be able but if those issue are there we are going to look at them and be able...(interrupted by the Speaker)

The Speaker (Mr. Steve Lelegwe): Continue Hon. Lentukunyei, take your seat Hon. Lesoipa

MCA Wamba North (Hon. Christopher Lentukunyei): Thank you Mr. Speaker for your wisdom and is it in order for the Hon. Member in giving his opinion as to why I give my concern, what I did is I gave a general concern of the entire County according to the statement that was directed to the Chair, in that view I think that the Hon. Member is out of order

The Speaker (Mr. Steve Lelegwe): I think that all of you Hon. Members are in possession of the order paper of 15th September 2015, where the Hon. Letura pursuant to the standing orders of this House requested a statement from the Chairperson of the sectorial committee on Education, Affairs and Sports, regarding the provision of food and water to the newly set ECD centers, we request the Hon. Chair that if he is not ready to table a comprehensive response tackling all the areas including giving responses on what is the situation of giving food rationing in all ECD centers of Samburu County, we will give you more time that you contact your sectorial committee and the respective County Executive committee Member for a comprehensive response, Hon. Lesoipa

MCA Suguta MarMar Ward (Hon. Shadrack Lesoipa): I do as you direct Hon. Speaker Sir

The Speaker (Mr. Steve Lelegwe): Thank you Hon. Lesoipa, you will report to this House, what is it Hon. Loldpep

MCA Maralal Ward (Hon. Elly Loldepe): Thank you Mr. Speaker, I am just concerned somehow and I want to go to a specific issue because the other questions will be answered as you have directed, the Hon. Chair has just said that the department had just found that the teacher is not trusted in Maradi ECD centers and that is why the department does not trust him with food

MCA Elbarta Ward (Hon. Romano Leakono): Point of order Hon. Speaker

The Speaker (Mr. Steve Lelegwe): Continue Hn. Leakono

MCA Elbarta Ward (Hon. Romano Leakono): Thank you Hon. Speaker Sir, I sincerely do not believe that the Hon. Member is in order (interrupted by the Speaker)

The Speaker (Mr. Steve Lelegwe): Order Hon. Loldepe, take your seat

MCA Elbarta Ward (Hon. Romano Leakono): After you have actually given your directions on the same matter, thank you sir, actually the Speaker has given the directions on this matter and I do not think that it is in order for us to continue discussing it (Applause).

The Speaker (Mr. Steve Lelegwe): Thank you Hon. Leakono for that contribution and the Chair have already given the directive to the Chair for Education, Sports and Youth affairs to report comprehensively to report to this matters as contained in the statement, I am sorry that I said on 15th but it is not Tuesday 8th September 2015 on the order paper at 2:30 pm, the statement was requested by Hon, Letura regarding the new ECD centers in Samburu County, Hon. Chair for Education, you will report on Wednesday at 2:30 pm, Hon. Leshoomo

MCA Lodokejek Ward (Hon. Jarias Leshoomo): Thank you Hon. Speaker, I stand to seek some clarifications on the issue of these statements, I think that we are supposed as a committee (interrupted by the Speaker)

The Speaker (Mr. Steve Lelegwe): Hon. Leshoomo, what statement are you seeking clarification on?

MCA Lodokejek Ward (Hon. Jarias Leshoomo): On the issue of Education Mr. Speaker

The Speaker (Mr. Steve Lelegwe): Order Hon. Leshoomo, we have just informed Hon. Members that this issue will be answered to, the response will be tabled on Wednesday at 2:30 pm, the Cahir has already ruled and there are no more contributions on the matter

MCA Lodokejek Ward (Hon. Jarias Leshoomo): I am not contributing to the issue but I just want some clarifications

The Speaker (Mr. Steve Lelegwe): Order Hon. Leshoomo, you will clarify on Wednesday at 2:30 pm, next week, because the Chair has already ruled on the matter and so more contributions and clarification and more orders are not accepted

MCA Lodokejek Ward (Hon. Jarias Leshoomo): I just want to request

The Speaker (Mr. Steve Lelegwe): Order Hon. Leshoomo, you are out of order, Hon. Leakonoi

MCA Elbarta Ward (Hon. Romano Leakono): Thank you Hon. Speaker, I raise to seek a statement

The Speaker (Mr. Steve Lelegwe): Sorry Hon. Leakono, before you rise on a point of statement, I refer you back to statement that was tabled by the Hon. Chair of Physical Planning, Housing and Urban development, response to a request for the statement by Hon. Benjamin Leitore, Member for Wamba West ward, to the sectorial committee on Physical Planning, Housing and Urban development regarding a parcel of land as contained in the statement, so I request your contributions Hon. Members on the statement, Hon. Leakono

MCA Elbarta Ward (Hon. Romano Leakono): Thank you Hon. Speaker Sir, mine is actually a concern on question Number. 2, whereby it is a bit difficult to understand, the paragraph in the second statement that says, The County Government and decisions to be taken and if the matter is deemed to be in the best interest of the County, that statement is a bit ambiguous and in a way it is not seriously telling us anything because this matter is already of interest and therefore when it is put in this manner actually it loses the meaning, in that parcel of land, we know that it was taken from the people Nkaroni unlawfully, in a way that is actually going to be addressed in the historical injustices and as such I think that the County Government has to secure the interest of the people, because they neither sold it, they never gave it to the purported owner, and I think that it is the interest of this County to see that its people, its citizens are not being robbed their rightful land by people who know better, so I would request that the Hon. Chair should actually see to it that question number 2 is answered correctly and that they may have to deliberate on it because it is for the interest of this County, for the people of the County and by the people of the County, thank you Hon. Speaker.

MCA Ndoto Ward (Hon. Leakono): Mr. Speaker, I am sorry but I have not really got what Hon. Leakono wanted exactly, but I think that if I try to put some information together of the information that he was talking about, then I think that the statement is clear that this is a weight issue and the department and the rest of the stakeholders sit down and discuss on the same, because for the issue of (inaudible) I think that this House must also be involved and that they must also approve such kind of moneys to be allocated for the same purpose, so I think that whatever happened already happened a long time ago and as much as it was not procedural, it requires a long process to be reversed back, we know that it is of the interest of this County, the people of this County and therefore consultations need to be done to ensure that we are within the law, in whatever step that we undertake, thank you.

The Speaker (Mr. Steve Lelegwe): Thank you Hon. Members, thank you Hon. Chair, if there are no more contributions, regarding the statement as tabled by Hon. Letura, we proceed to the next statement, Hon. Leakono

MCA Elbarta Ward (Hon. Romano Leakono): Thank you Hon. Speaker Sir, pursuant to standing order number 41/2c, I hereby request from the statement from the Chairperson of sectorial committee on Cooperative Development, Trade and Tourism concerning the Baragoi conservancy vehicle, this vehicle was withdrawn from the conservancy under unclear circumstances, there are claims that the vehicle was drawn due to accusations of misuse by the conservancy manager, if this is the case then it becomes unfortunate for the supposed beneficiaries of this vehicle, behavior of a Chair would not have affected the operation of the whole conservancy vehicle which affects the lives of many people and wildlife, Hon. Speaker Sir, in view of this, the chairperson should inquire into and report on, what happened to this vehicle, what is the future plans for it and why should it be returned with clear rules and responsibilities to Baragoi conservancies.

The Speaker (Mr. Steve Lelegwe): The Hon. Chair of the sectorial committee on Cooperative Development, Trade and Tourism, Hon. Grace Lenolkirna.
