- That the nomination is committed to the Sectoral Committee on Tourism,
   Trade, Enterprise Development and Cooperatives for vetting and tabling of a report within the prescribed timeframe.

The Committee shall consider:

- The procedure used to arrive at the nominee and the shortlisting criteria,
- Any legal or constitutional requirements relevant to the office, and
- The nominee's suitability, qualifications, and experience for the position.

Let the Committee and Members treat this matter with the urgency it deserves.
