This milestone marks a crucial development in the county's efforts to ensure effective legal oversight, uphold the rule of law, and protect the interests of its residents.

Honorable Speaker,

The establishment of the County Attorney's office in Samburu County was prompted by recognition of the need for specialized legal counsel to address the diverse legal challenges facing the county. This office is tasked with providing legal advice and representation to the county government, ensuring that its actions align with the constitution and statutory requirements. Key responsibilities of the County Attorney's office in Samburu County include:

- 1. **Legal Advisory Services:** The County Attorney's office offers expert legal guidance to county government departments, helping them navigate complex legal issues, contracts, and policies while ensuring compliance with the law.
- Litigation Management: The County Attorney represents Samburu County in legal proceedings, both as a plaintiff and a defendant, safeguarding the county's interests and resources.

The current situation, where the entire office relies on the efforts of a single County Attorney, has raised significant concerns about the quality and timeliness of legal services provided to county agencies and officials. This situation not only places immense pressure on the County Attorney but also hinders our ability to create and implement the numerous policies necessary for the county's progress.

In view of this, the Chairperson should inquire into and report on;

- 1. Why did the County Administration not take immediate action to address this issue?
- 2. Why is the office of the County Attorney not employing adequate legal staffs, in order to alleviate the current workload?
