Pursuant to Standing Order 45(c), I hereby request a statement from the Chairperson of the Sectoral Committee on Environment, Water and natural Resources regarding implementation Status of Financing Locally-Led Climate Action (FLLoCA) project in Samburu County

Honorable Speaker,

The Financing Locally-Led Climate Action (FLLoCA) is a five-year initiative launched by the Government of Kenya, supported jointly by the World Bank and various other international donors. This program is designed to empower local communities by delivering locally-led climate resilience actions and enhancing the capacity of both county and national governments to effectively manage climate-related risks.

Honorable Speaker,

The objectives of the FLLoCA project are as follows:

1. **Capacity Building:** Strengthen the capacity of county-level institutions and local stakeholders, particularly the Ward Climate Change Planning Committees (WCCPCs), to accelerate climate resilience efforts. This includes training programs and resources to ensure effective planning and implementation of climate actions at the local level.
2. **Community-Led Initiatives:** Support community-led local initiatives aimed at enhancing resilience and promoting sustainable practices. This encompasses projects focused on agroecology, sustainable water management, and community forestry, which are crucial for building adaptive capacity in vulnerable areas.
3. **Access to Green Technologies:** Increase access to green and environmentally friendly technologies to foster low-carbon, climate-resilient development within the county. This involves the promotion of renewable energy sources, efficient water management systems, and sustainable agricultural practices.
4. **Policy Development:** Support the development and strengthening of policy, legal, and regulatory frameworks at the county level to facilitate access to climate financing for building local resilience. This includes creating incentives for private investment in green technologies and ensuring that climate action aligns with local development plans.

Honorable Speaker,

The FLLoCA program is being implemented by the National Treasury through the Program Implementation Unit (NTPIU) and the County Government through the County Climate Change Unit (CCCU). The program emphasizes collaboration among various stakeholders, including local governments, non-governmental organizations, and community-based organizations, to foster a collective approach to climate resilience.

In the statement, the Chairperson should inquire into and report on:

- 1. The implementation status of the FLLoCA fund for the year 2023-2024, including details on the allocation of funds, project timelines, and progress made in achieving the outlined objectives.
- 2. The mechanisms in place to monitor and evaluate the effectiveness of FLLoCA-funded projects, including feedback from local communities and stakeholders involved in the initiatives.
