Hon. Members, there is a response for Statement and it is therefore notified THAT the following statements are due for response today on Wednesday 5th, 2024 at 9:30 AM pursuant to Standing Order 45(C);

1. **Statement No. 028/2024 Requested** by Hon. Lawrence Lorunyei to the Chairperson of the Committee on Labour, Social Welfare, Justice and Legal affairs in regards to the status of the village councils in the county.

Chairperson of the Committee on Labour, Social Welfare, Justice and Legal affairs, (Hon. Leleruk James): Thank you Mr. Speaker, I am still requesting for more time as we want to bring in a comprehensive report and we do not want to bring a half-page report, so I am requesting to table it on Wednesday and also because most of my committee members are not around and we need to go through the report as a committee before bringing it to the Hon. Members, Thank you Mr. Speaker.

MCA Nachola Ward, (Hon. Lorunyei Lawrence): Thank you Mr. Speaker, I am not satisfied on the reasons why the Chairperson is requesting for more time. We are here guided by the law aand by having an office that is not operating for quite some time, while it had been well established, had funds allocated to it, and it is an office that is on the ground; the village council. This confusion brings in fake village councils that are not guided by the law.

We are here to operate according to the guidelines of the Constitution, the County Government act and any other rules. Having said that, since devolution for more than 10 Years now that the office is in place and has a term limit of 5 years as we know, after that the recruitment is done again. This office has not been operating for 1 year and 10 Months and I do not know why there is no any seriousness shown by the department concerned on this matter. It seems that there is a deliberate concern on it Mr. Speaker, because we understand that there is another vague one operating.

This Statement was requested long ago before we went to recess and was even supposed to be responded to yesterday, time was asked again for it to be presented today and now again the Chairperson is still requesting more time. It is not a research that is supposed to be done, we just

want to get what is in the reports, they are refusing to give us the information that we need and I ask for the Chairperson to avoid giving us excuses while we want to deliver services to our people. Thank you Mr. Speaker and I urge that through your intelligence that you will put the seriousness that is needed, that if it will be postponed next time it will be a matter of Motion whereby this house will put on their resolution to enforce the operation of the office of the Village councils.

Temporary Speaker, (Hon. Leitoro Jeremiah): Hon. Minority Leader, who also adds up as a representative of the government and also the Chair for the Committee on Labour, we all understand that this thing has taken a long time and has been overdue for response and indeed as said by the Hon. Lorunyei, those offices are vacant and need to be operational to do the functions assigned to by the County Government, we have not heard enough reason as to why there is no response for the sought statement while you promised yesterday that you would get the report this morning, perhaps maybe if you have any information that may explain about this, then we can give consideration on what you are requesting about.

Chairperson of the Committee on Labour, Social Welfare, Justice and Legal affairs, (Hon. Leleruk James): Thank you Mr. Speaker, it is true that I promised yesterday to table the report, but regarding on what the hon. Member for Nachola Ward requested like Bank Statements and the Payment schedule, so it is a document that is been prepared and does not need rush. Then after bringing to the house, the Hon. Members might start saying that it is not enough, so we wanted to make a comprehensive report. I promise to bring the report and nothing will be left out and you will get all the response, I am also aware of the seriousness as to why the offices are not working but be assured that on Wednesday we will bring the report at 2.30 PM, Thank you Mr. Speaker.

Specially Elected MCA, (Hon. Lenamatiyio Silapia): Thank you Mr. Speaker Sir. I also stand to raise my sentiments on the matter of the Village Council office; as said by Hon. Lorunyei that we have one year and 10 months without the Village Council office in place. This may cause some disconnection between the office of the Governor, the community, office of the Governor and also the operations of the County from the top office to the village level.

Through your guidance, we need something to be done. We need this office to be in place. I know 2023/2024 there is an allocation of the Village Council and we want to know where that money goes to. Hon. Speaker, Hon. Chair and the Majority Leader please do something so that we can have an answer on time, thank you.

MCA Suguta Marmar Ward, (Hon. Leleruk James): Thank you Mr. Speaker. I know the concern of the Hon. Members and as I said earlier I am not working alone; I have my Committee. Even if I have that report now I cannot disclose since we have not set as a Committee so that we can decide and agree, I cannot decide when we are not all because in a normal procedure we need to see if the documents have been requested through because you will defend on the floor of this House. I request more time because the other Members are not here and also again the...

MCA Nachola Ward, (Hon. Lorunyei Lawrence): Thank you Mr. Speaker, when we requested the Statement, we requested to the Department through the Chairperson and the response coming to this Hon. House is from the Department through the Chair. The Committee gives their observations and recommendations. That is not at this stage. It is very concerning when the Chairperson says that he has the response here and he is just denying because all the Members are not there. Can you direct him to read the Statement now, thank you.

I wish that you give him time to sit with the Committee to look at the report, thank you.

Temporary Speaker, (Hon. Leitoro Jeremiah): Now I want to give direction on this matter; the Hon. Minority Leader who also doubles as the Chair for this Committee, I want you and your Committee to take your work seriously (*Applause*). Going forward as I postpone this response to next week on the 12th on Wednesday at 2:30 pm we anticipate that the Committee on Labor should summon the County Secretary on the above matter and try as much as possible to obtain the response from the Department. Failure to which on that very day on 12th June 2024 if there is no response from the Department then this House will form an AD HOC Committee to investigate on that matter then we will be able to get response that is the direction.

The next Statement "Request for Statement number 022/2024 requested by Hon. Patrick Leerte to the Chairperson of the Committee on Education and Vocational Training in regards to the status of ECD in Poro Ward.

MCA Suguta Marar Ward, (Hon. Leleruk James): Thank you Mr. Speaker let me read the statement on behalf of Honorable Leerte who is not around, Honorable Speaker pursuant to standing order 42 sub section 2 I hereby request a statement from the chairperson of the committee on educational vocational training regarding to early childhood development centers, honorable speaker the constitution of Kenya 2010 separates government onto two levels, National and County level article 6 dives the territory of Kenya into 47 counties then Kenya is transiting into from a centralized government into a devolved system of government the constitution establishes a devolves system of governor in accordance with the objects and principles of devolution as articulated in article 174 & 175 the constitution of Kenya is a supreme guiding law on education.

No 4, which obligates state to ensure that all children access a quality childhood development, care a pre-primary education so that they will be ready for formal schooling, pre-primary provides children to enhances their cognitive social morals spiritual and emotional and physical development as well as a aseptic aspects, the early childhood development ECED framework is based on principles that are universally accepted as a forming the corner stone of a quality early childhood development services and programs the policy ensures that the holistic needs of the young children are met maximizing the realization of their full potential safe guiding the rights and welfare of the child as per the children act 201, in view of the chairperson of the sectorial committee on education and vocational training should be inquire into and report;

1) What is the current progress on the construction of the 60 toilets by the departments across the county?

2) Has any progress been made in constructing the toilets in poro ward because the ward has not benefited from it?

3) What plans does the department have top address the issue of the teachers transfer from Lorrok ECED to Maralal without providing the replacements?

4) When can we expect the replaced teacher to be provided?

5) Is there a significance shortage of the teacher's county wide?

6) What strategies does the department have in place to recruit more teachers?

7) Was the previous recruitment sufficient to meet the demand?

8) Can the department consider allocating funds to honorable members to each ward to recruit ECED teachers as the interns in their respective wards?

9) What is the current status of the bursary programs?

10) Is the department aware of the case in Poro ward where students received the bouncing chaques?

11) Are you aware that providing a bouncing chaques to students is considered a criminal offence?

12) How does the department to effective manage and revive the non-functioning Sirata vocational training center?

- 13) What are the specific plans to recruit the new students for the institution?
- 14) How will the department develop the institution to make it well known in the county and beyond? Thank you Mr. Speaker.
