PRAYER

The Speaker, (Mr. Lenamarle Stephen); Hon. Lemartile.

MCA Wamba West, (Hon. Lemartile Francis); Thank you honorable speaker. Pursuant to standing order 45C/1 I hereby request for a statement from the chairperson of the secretarial committee on roads, transport and public works regarding the current status of the following roads in Samburu East, Wamba West Ward.

Road number one is Samburu National Reserve road budgeted on the financial year 2022/2023. Second road Mr. Speaker is a new road Pulupulu to Lopesiwuo to Matakwan Road budgeted on the financial year 2023/2024.

Honorable Speaker paragraph five of the fourth schedule to the constitution 2010 provide for the functions and the powers of county government on county transport includes county roads, street lights, public roads, transport, traffic and packing and also county public works and services including storm water management system in buildup areas and water and sanitation services have been devolved to the county government.

Honorable Speaker in the statement the chairperson should inquire into and report on;

1. An updated on the current conditions and status of the above mentioned roads include details on any completed maintenance, ongoing repairs or construction work.
2. He should report breakdown of the budget allocated for each of the above roads project for the respective physical year including details on funding sources any revision made to the budget and how allocated funds are being utilized.
3. Further Honorable Speaker, the third should vanish details on the contractors awarded the tenders for this roads projects along with any pertinent information on the selection process and contract terms.
4. Fourth Honorable Speaker the chairperson should get specified date when each of the above roads project commence and the completion date.
5. The fifth is provide more details outlined of the scope of work agreed upon for each road project include specific such as the total length of the road involved starting point and end point for each road Mr. Speaker and type of repairs or construction undertaken in any other pertinent related to infrastructure enhancement

6. Last Mr. Speaker I wish also to get an update on the payment status for each of the road project include details of payment made to contractors any outstanding payment and confirmation that payment are in accordance with contractual agreement.

Thank you Mr. Speaker, those are the six questions or information I require from the chairpersons of roads. Mr. Speaker this roads especially the second one Pulupulu- Lopesiwuo it is a new opening which it was the Wamba West community requested that opening and up to date last weekend I was from the ward, nothing was done from those roads so the department should give us detail of it and more so especially on SNR roads the department should be specific of which roads have they done because each and every year we have been allocating funding not little amount, a lot of funds but the roads are still in pathetic situation. Thank you Mr. Speaker.

The Speaker, (Mr. Lenamarle Stephen); Chairman roads?

MCA Lodokejek Ward, (Hon. Lekuchula David); Thank you Mr. Speaker I request maybe one week, the next week Thursday I think the department will have come back with the response concerning the requested statement. Thank you.

MCA Suguta Ward, (Hon. Leleruk James); Thank you Mr. Speaker I beg to the following motion that taking into consideration of the committee on labour, social welfare, justice and legal affairs with its report on the vetting of Mr. Daniel Moss Lentiyo nominee to the position of secretary CEO to Samburu County Public Service Board laid on the table of the assembly on Tuesday June 18th,2024 and pursuant to the provision section 9/2 of the public appointment of the county assembly approval act 2017 and section 58 of the county government act 2012 this county assembly approves;

1. The appointment of Mr. Daniel Moss Lentiyo as Secretary CEO Samburu County Public Service Board.

Thank you Mr. Speaker and I ask honorable Stacy to second the motion.

The Speaker, (Mr. Lenamarle Stephen); Honorable members I now propose the motion that taking into consideration the recommendation of the committee on labour, social welfare, justice and legal affairs in its report on the vetting of Mr. Daniel Moss Lentiyo nominee to the position of Secretary CEO to the Samburu County Public Service Board laid on the table of the assembly on Tuesday June 18th 2024 and pursuant to the provision of section 9/2 of the public appointment that is county assembly approval act 2017, and section 58 of the county government act 2012 this county assembly approves;

1. The appointment of Mr. Daniel Moss Lentiyo as Secretary/CEO Samburu county public service board.

Hon. Leleruk.

MCA Suguta Ward, (Hon. Leleruk James); Thank you Mr. Speaker, section 58/1 sub section 2 and sub section 3 of county act 2012 exception to the county public service board in accordance to the section 58A sub section 1 of the county government act 2020 that provides that they should arise a vacancy in the county public service board, the governor shall nominate and with the approval of the county assembly appoint the Secretary/CEO of the board.

Following the nomination of Public Service Board Secretary/CEO by his excellency the governor in accordance to section 58A sub section 7 of the county government amendment act 2020 and pursuant to section 8/1A of the county government act 2012 the following person was nominated, Mr. Daniel Moss Lentiyo Secretary/CEO Samburu County Public Service Board

The nomination of Mr. Daniel Moss Lentiyo was conveyed to the Speaker through a letter, SGS/GVN/CA/CPSP/VOL.4/123 dated 16th May 2024.

The nominee's Curriculum Vitae and other testimonials were enclosed in the letter. On 4th June 2024 in accordance to the devolution Section (7), Sub-section (1) of the Public appointments County Assembly approval Act 2017, the Speaker reported the receipt of the notification to the County Assembly, the Nomination of the Secretary C.E.O of Samburu County Public Service

Board Nominee in accordance with Section 58 (a), Sub-section (1) of the County Government Amendment Act 2020 and Pursuant to Section (8), Sub-Section (1), Paragraph (a) of the County Government Act 2012 and Standing Order No. 200, Sub-section (4), Paragraph (f) of the County Assembly of Samburu Standing Orders, the name of the Nominee Mr. Daniel Moss Lentiyo was referred to the Committee on Labour, Social Welfare, Justice and Legal Affairs for vetting and reporting to the house within 14 days.

Consequently, in Accordance to Section 7(4) of Public Appointments County Assembly Approval Act of 2017, the Clerk of the County Assembly placed a Public notice on 4th June 2024, inviting the public to submit memorandum by way of written statements on Oaths or affidavit on the stability or otherwise Nominee in accordance with the Public Appointments County Assembly Approval Act 2017. The Public Notice indicated that the Submissions were to be received by Monday 10th June 2024 at 5.00 PM. By close of submission period, the Committee did not receive any memorandum touching on the stability or otherwise on the Nominee.

The Nominee appeared before the Committee as Scheduled on Tuesday 11th June 2024, for approval hearing in accordance to the revision of the Constitution of the County Government Act 2012, Public Appointments County Assembly Approval Act 2017 and The County Assembly of Samburu Standing Orders on instability or otherwise for Appointments to be Secretary CEO of Samburu County Public Service Board pursuant to Section 58 (a) ,Sub-section 1,2 and 3 of the County Government Act 2020 and Section 8/Paragraph 1 and Sub-Paragraph (a),the Committee observed the nominee, Mr Daniel Moss Lentiyo met the integrity threshold, demonstrated knowledge of topical, administrative and tactical issues touching on the position he has been nominated for and had exquisite abilities, academic qualifications and professional experience to be approved for appointment as the Secretary CEO of Samburu County Public Service Board.

Having conducted the Approval hearings for Nominees in accordance with the Constitution County Government Act 2012 Public Appointment, County Assembly Approval Act 2017 and County Assembly of Samburu Standing Order No. 200/Sub-section (4)/Paragraph (f), the Committee recommends that this assembly:

1. Approves the nomination of Mr. Daniel Moss Lentiyo for Appointment as the Secretary CEO to the County Public Service Board for His Excellency the Governor.

May I take this opportunity to, thank all members of the committee for their input and valuable contribution and time during the Approval hearing and report writing.

The Committee also takes this opportunity to thank the office of the Speaker and the office of the Clerk of the County Assembly of Samburu for the technical support they accorded to the committee during this exercise.

On behalf of the Committee on Labour, Social Welfare, Justice and Legal Affairs and Pursuant to the provision of Section 9(II) of the Public Appointments County Assembly Approval Act 2017, and Standing Order No. 200/Sub-section(IV)/ Paragraph (f), it is my pleasant duty to present to the house the report of the Committee on Labour, Social Welfare, Justice and Legal Affairs of the Approval Hearing of the Nominee for the Appointment to the Position of the Secretary CEO of the Samburu County Public Service Board.

Mr. Speaker I'll go up to the Committee's Observation and Findings, the Committee having considered his Curriculum Vitae and heard his oral Submission during the vetting exercise, the Committee made the following observations.

1. He is a Certified Public Accountant of Kenya (CPAK), Member No. 20433.
 - A Certified Secretary of Kenya (ICSK), Member No. 4003.
 - A Certified Information System Audit and Control Associate with a Masters Degree in Business Administration (MBA- Finance Option) from Nazarene University and Bachelor's Degree in Commerce, Accounting option from KCA University.
2. He has a Wealth of over 10 Years Professional Experience, a practicing Accountant and an active member of the Institute of Certified Public Accountants of Kenya (ICPAK) and the Institute of Certified Secretaries of Kenya (ICSK).
3. The Nominee has never been charged in a court of law, has no potential conflict of interest and has fully complied with his tax obligation.
4. He has never been dismissed from Office due to contravention of Article 75 of the Constitution which deals with Conduct of State of Staffs that are adversely mentioned in any anticipatory report of County Assembly or Parliament or Commission of Inquiry.

The Committee found the Nominee suitable for the Appointment as Secretary CEO of Samburu County Public Service Board. Having conducted the Approval Hearing for the Nominee Pursuant to Article 179-II(b) of the Constitution of Kenya Section 7 of the Public Appointments County Assembly Approval Act 2017 and the County assembly of Samburu Standing Orders No. 193 Sub-section IV, it recommends that the Assembly approves the Nomination of Mr. Daniel Moss Lentiyo for the Appointment as the Secretary CEO of the County Public Service Board, Thank you Mr. Speaker.

MCA Loosuk Ward, (Hon. Lenamparasio Phelix): Thank you Mr. Speaker, I stand to support the motion but with some few reservations. The first one is that I think that am so happy now that we are approving this gentleman Mr. Daniel Lentiyo to be the CEO of the County Public Service Board because of a lot pending issue that deals with the Public Service Board especially the replacement of the ECDE Teachers that has been long overdue. We know think that having approved this gentleman, the replacement of the ECDE Teachers should be given the first priority, because we are having a number of our ECDE centers without teachers.

I think recently while we were with the Budget Committee from the department, we noted that out of 524 ECDE centers, 221 has no ECDE teachers and we have a number of ECDE teachers to be replaced. We don't want to joke with our early learning Institutions because the kids need to be with the teachers, so I think kindly that is my own reservation. We also as well have a lot of promotions that were delayed pending the approval of this gentleman, so I think that should be the first activities he should undertake.

Mr. Speaker, there is one major reservation that I just want to make as an individual and as a member of Loosuk Ward, that this County should try to embrace the spirit of maybe letting our young boys and girls compete in this Public Appointments.

Whenever we advertise a public appointment, we should give this young men and women that freedom of competing fairly. I just want to categorically say here that this County is having a very bad trend where Public Appointments are being given *barazas* all over Our County and I don't think that should be the way to go. So, Mr. Speaker I just want to beg the Hon. Members that as a house we should be very strict on that. That a public appointment is a public

appointment, they should be advertised, people should apply, go for interviews and the people to be awarded as per how they perform during the interviews.

There is no need of maybe giving here work or employment based on who you know, we have seen a number of times that the employer the person that performs very exemplary the interview is denied opportunity merely because he does not know anybody in the county or maybe he does not fall under the county.. he is not a good friend of the political divine, so to me personally that is one of the biggest reservation I want to make, that in this county public appointment should be advertised and people be given opportunity to apply and compete fairly through interview otherwise the trend that we are nowadays seeing that these public appointments are being handed over or given out during public Baraza's should stop. If we want our young boys and girl to grow those who have gone to school then that should be the spirit, otherwise if you continue ditching out these public appointments, I think that is even criminal it is not supposed to be like that and I just want to reserve that as much as we support the work that the committee has done kindly the chair, just reserve those points and they are supposed to be seriously taken, those are my few remarks as much as I support the motion, thank you Mr. Speaker.

Specially Elected Leader, (Hon. Lenamatiyo Silapia): Thank you Mr. Speaker, I stand to recommend the committee for the good report they have brought to this House Mr. Speaker. When you look at this report I saw and I am seeing the criteria that the committee examined the nominee against the following criteria and when you look at the academic qualifications of the nominee he qualified to be the CEO because he is holding a degree in business administration which also gives more support on the same position. I know this county is in need of the CEO of the County Public Service Board and it is the right time now that the committee has examined the nominee and they have come with the report and will have looked at the little time we have looked at it and the nominee qualified to be the CEO.

The little that I know about Mr. Daniel Moss Lentiyo is that he is a very humble man, and if given that position, I think we need people who are very humble in this position, who can listen everybody and deal with it. The other issue here is that the knowledge of the relevant subject or the knowledge of the nominee. I went through this report and I saw Daniel Moss Lentiyo has 10 years' experience which also supports him to be nominated as the CEO. Let me appreciate the committee led by our minority leader and I really support the report and I call upon the

Honorable Members let us support the report as it is so that that office be in place, thank you Mr. Speaker.

Nachola Ward MCA, (Hon. Lorunyei Lawrence): thank you for giving me this chance Mr. Speaker, to give my concerns about the appointment, it seems that we only transits from a point to a point of an approval but no taking things very seriously Mr. Speaker. According to the regulations, any appointment must be advertised and everybody must be given a chance to compete for the position. Am taking the concerns of Member from Loosuk Mr. Speaker, may I give ...

The Speaker, (Mr. Lenamarle Stephen): Point of Order Hon. Lorunyei from Hon. Leleruk

Suguta Ward MCA, (Hon. Leleruk James): Mr. Speaker, I just want to make this clear, that this position was advertised, it was in Kenyan Gazette, Social Media, everywhere and people applied for the position those who qualified. The reason why maybe you said it might not have been advertised every law must be followed.

The Speaker, (Mr. Lenamarle Stephen): continue Hon. Lorunyei... Point of Order from Hon. Lenamparasio

Loosuk Ward MCA, (Hon. Lenamparasio Felix): Thank you Mr. Speaker, as much as the position was advertised, I think it was long given before it was advertised, those are the concerns that we are raising that you should not go and give a position before advertising it. We all live here in Samburu county the position was give before it was advertised but it was just advertised then interviews were done, So, Hon. Lorunyei I just want to support your point that this is the trend that is in this county you give out a position before advertising it.

(Point of Order from Hon. Nakinyi Jane)

The Speaker, (Mr. Lenamarle Stephen): Hon. Lorunyei you can continue

MCA Nachola Ward , (Hon. Lorunyei Lawrence): Mr. Speaker according to the Standing Order, there is no sequence of Standing Order Mr. Speaker, the Members I do not know why they are hot now when I am talking, when I am trying to give my opinions, they should listen to my concerns and they will also be given their chance. This House is the House of the law and we must follow the law and we are here House of the Representatives, when we are representing we

represent the ward that we come from and because of the issue now arising it is about oversight and legislation has the process been followed? The procedures followed? According to the constitution? According to the county government act? According to any other law? Mr. Speaker.

That is why I said that if things were going in order there would have been no such feeling, when you see some feeling some mess. We need this county to be of integrity, sincerity and to be for the people. We are for the benefits of the people of Samburu County and the benefit of our county but connections, nepotism, tribalism, it is this House that does its role of oversight to see whether the process was transparent.

I am not opposing the nominee I am just concerned about the process, the procedure and the law, it should be followed to the latter because everybody looks for an opportunity. We need to be dignified because of this House of dignity. We have been given the laws, The Constitution, The County Government Act we are not just going to be rubberstamped Mr. Speaker, we are also believe I ourselves by being the... of executive.

This House is independent and executive is independent that's why we have got two arms of the government making the county government. My concern is just like the Honorable Member of Loosuk let us try to be white, let us try to be transparent, let us give everybody opportunity, otherwise I support without reservation thank you Mr. Speaker.

Specially Elected Leader, (Hon. Stacy Nareyo): Thank you Mr. Speaker, first of all I really thank the office Speaker and the clerk for giving us the technical support we received during the interview. Secondly I would also want to let the Honorable Members know that we have take note on the comments and the committee on labor does not compromise when it comes to appointments and we do not accept clan appointments and we want to assure you Hon. Lorunyei and Hon. Caunda that that the process was free and fair.

The interview was done comprehensively, we want to assure you that the interview of CPA Moss Lentiyo was free and fair, he is eligible and equal to the task with an experience of over ten years. I want to assure the House that the committee on labor does not accept any clan appointments in the process thank you so much. I want to request the Honorable Members to

kindly approve the nomination of CPA Moss for the effective coordination within the board, thank you Mr. Speaker.

The Speaker, (Mr. Lenamarle Stephen): Hon. Sarah

Specially Elected MCA, (Hon. Lekirenyei Sarah): Asante sana Mheshimiwa Spika, ningependa kuunga mkono mjadala wa siku ya leo kwa kusema kwamba katika Kaunti yetu ya Samburu tulikuwa na shida nyingi kwa sababu hatukuwa na katibu wa bodi ya kaunti katika idara ya utumishi kwa umma; siku ya leo tunaweza kujadiliana na vile tujuavyo shule zetu za chekechea zina changamoto sana kwa ukosefu wa katibu. Mfano ni walimu wa shule za chekechea ambao wengi walikua wafanyiwe mabadilisho lakini hadi sasa hawajafanyiwa hivyo.

Tuko hapa leo kupitisha mjadala wa katibu ili watu wetu waweze kupata ubadilisho kwenye vituo vya chekechea. Tuko na changamoto nyingi katika matangazo, asante Mheshimiwa Spika.

Specially Elected MCA, (Hon. Nakinyi Jane): It was a Point of Order but I can still talk about the appointment of the Secretary County Public Service Board; the way I see the advertisement and the procedure that was done for this officer it was really fair as Hon. Stacy has said. I urge my colleagues to approve these names. We have a lot to do. In the Health Department we have a lot of things pending like the promotions and if it is not done soon and the quickest way possible then there will be hiccups in the Department.

Hon. Members let us approve the name and the appointment of the Secretary, we have seen that he has been working in our County and he has a reimbursed experience especially in his field. Thank you Mr. Speaker for this chance and also listening to me but next time when someone says Point of Order just honor that person because we see as if...

The Speaker, (Mr. Stephen Lenamarle): Hon. Nakinyi you are not supposed to correct the Chair, the Chair has the mandate and a luxury to do whatever he wants to do, so thank you very much. Hon. Deputy Speaker.

MCA Wamba East Ward, (Hon. Lelengeju Jackson): Thank you Mr. Speaker. I stand to also support the Motion. I thank the Committee on Labor, Social Justice and Legal Affairs for the commendable job they did during the Vetting and approval of Mr. Daniel Moss Lentiyo as the Secretary CEO Samburu County Public Service Board, much has been said and sentiments

echoed and from the look of things and his experience he is capable of the job and we wish him well.

I have no doubt in his abilities to perform the duties before him knowing that a lot is waiting in the office, it is my prayer that authorities allow you to practice independent professional work so that we move the County forward.

Given the weight, the Calendar, what is in the tray today and reading the mood of the House, I beg that we conclude the approval of Mr. Moss Lentiyo and continue with other matters, thank you Mr. Speaker.

MCA Nyiro Ward, (Hon. Lemoosa Jonathan): Thank you Mr. Speaker Sir. I wish to extend my gratitude to the office of the Speaker and the Clerk for the huge support financially, moral and any other support given to the Committee since I sit in the Committee.

I urge Members to support the whole report because we want to understand the role of Committees and given statutes and orders; there was a panel that did the interview and forwarded the name to the Committee on Labor for simple reason to vet the suitability and qualification of the nominee; but when you look at page 10 of the report that gives the criteria and the details of personal biodata, Mr. Moss is overqualified because he has a Master's in Business but very particular is the second one where he is actually a Certified Secretary of Kenya(CSK) and this is the position proposed by the leave of the House to handle. That is our first role as a Committee, we were to vet suitability of the nominee and looking through his biodata he is more qualified because he has other credentials.

Secondly, the Committee would have considered any public Petition either private or public but we sat as a Committee and there was no Petition that would have raised an alternative, decline or give negative report. There were no public or private Petitions. I also agree with the Hon. Phelix for Loosuk that canvassing is a criminal offense but here comes a situation whereby we are guided by the Standing Order number 93 of this Hon. House that guides us where I want to say responsibility for Statement of facts; there were no such information that whatever was happening, the interview or the nominee had canvassed before; this gives us a privilege to believe there was no canvassing before because our Standing Order number 93 calls for Statements of Facts where it's says in number one with your permission I want to put it that a

Member should be responsible for the accuracy of any facts which the Member alleged to be true and maybe requested to substantiate any such facts instantly.

When we had no such matters we want to believe that there was no canvassing, if there were they would have tabled together instantly as the Standing Order says. Nevertheless, we want to plead with the Members of the House that in future if there are such we should also be following criteria or statutes to discredit any report.

With this few supports I plea with the Hon. Members that yes there could be some concerns but the criteria which are forwarded to bring into light such, I do not deny that maybe persons might be having a prior knowledge on such but actually when they are not instantly placed on the House then we want to say that is a bit out of Order.

So Mr. Speaker, with all due respect, just as the other members have said, I want to join them saying that this position is very important to the County Public Service Board of Samburu and more so the CEO is not the ultimate authority, he just works with the board that gives the ultimate resolutions, and he is just the secretary to the board and so does not have that power to decide along the direction on which the board takes. Maybe in future we will try and see how much, we take merits but sad enough that at this house we do not employ, we do vetting and approvals to what is guided, Thank you Mr. Speaker and with those remarks, I humbly urge the members that we dispose this such that our young boys and girls get employed as it is a dear need.

MCA Ndoto Ward, (Hon. Lealmusia Ali): Thank you Mr. Speaker, Allow me to say a bit about this great man who is about to be approved by this Hon. House. CPA Daniel Moss Lentiyo, is a young, energetic and professional, a man of integrity and I have screen-played him and found him fit for this position just because he is certified by the Institute of Certified Secretaries of Kenya (ICSK). You know he really fits this position and that's the reason why I stand here to really thank the office of the Speaker for their support and also my colleagues from the Committee and thus urge this house that without much time wasting, let us approve CPA Daniel Moss Lentiyo, Thank you Mr. Speaker.

MCA Lodokejek Ward, (Hon. Lekuchula David): Thank you Mr. Speaker, I support the motion.
