2. The Public Accounts and Investment Committee- your timely review of Audit reports currently under consideration is essential to uphold fiscal responsibility and transparency in our county operations I am confident in your dedications to maintaining high standards.

3. Budget and Appropriation Committee- tabling of the public participation report on Annual Development Plans (ADP) for the FY 2025-2026.

4. Finance Economic Planning and ICT- Consideration of the Samburu County Finance Bill
2024 which is already overdue and tabling of the Samburu Monitoring and Evaluation Bill 2024
Public participation report.

Hon. Members let us approach this responsibility with diligence and unity. Working together to serve the people of Samburu with integrity and purpose, thank you for your continued commitment.

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): Thank you Mr. Speaker, first of all let me take this opportunity to congratulate my friend Janet, I have known Janet for quite some time for securing this position. Mr. Speaker I was not to contribute but just because of The guidelines that we are giving there that the committee should their work, I think I am the chair for budget and I am very happy we you are reminding us that you should bring our Report on ADP. I think we only have the Report writing. We did our public participation so I know very soon we just table that Report. But there is one issue that gotten my attention there. The issue of the finance bill, it is very unfortunate that this House of rules, we are not following rules, if you go through the public finance act of 2012, finance bill in every County Assembly have to be submitted, considered and approved by 30<sup>th</sup> of September.

Today is 29<sup>th</sup> of October; those are the 30 days past the deadline. So Hon. Speaker you that the department the committee of finance should fasten the tabling of the Report here that is long overdue, I am still waiting your indulgent of the same because there is no need for us to table reports here that are long overdue using our resources very much knowing that the time has elapse.

If you just looked at public fiancé act, you know after every 90 days, from the day of the estimates are approved, that is seemed to be 30<sup>th</sup> June, he fiancé bill has to be table to this House, considered and approved but is 30 days and we have not even seen the tabling of finance bill in this House. You know a whole County implementing budget without a road mop on where they should get resources from, I do not see the reason why we come here to be used As rubber stamps by the executive especially the CEMC finance taking us for a ride , the last time we have CFSP tabled on 13<sup>th</sup> March, 2024 with only a single prior to the day to the approval dates of CFSP.

We are here again now past the dates that the law provides for submission and approval of finance bill. We do not this we are ready to use our money as the County going for public participations for some work that is mandatory obligations by law provided by PFM act. It is mandatory. You know whether the CEMC likes it or not, the finance bill has to be tabled and approved in this House. So maybe somebody may advise us on what now to do. So should we just do the things for the sake of doing? We should not be taken us rubber stamps by the Executive If the CEC Finance is not...
