### **MOTION**

**MCA Suguta Marmar Ward,** (Hon. Leleruk James): Thank you Mr. Speaker. Pursuant to Standing Order number 47 I beg to move the following Motion that this House debates and approves the report of the Committee on Labor, Social Welfare, Justice and Legal Affairs on the Vetting of the County Public Service Board Selection Panel Nominees. I call Hon. Sera Lekirenyei to second the Motion.

Specially Elected MCA, (Hon. Lekirenyei Sera): Thank you Mr. Speaker Sir. I second the Motion.

**The Speaker,** (Mr. Lenamarle Stephen): I now propose the Motion that this House debates and approves the report of the Committee on Labor, Social Welfare, Justice and Legal Affairs on the Vetting of the County Public Service Board Selection Panel Nominees.

**MCA Suguta Marmar Ward,** (Hon. Leleruk James): Section 58 (1), (2) and (3) of County Government Act 2012 Establishes the County Public Service Board. Whenever a vacancy arises in County Public Service Board Section 17 of the County Governments (General) Regulations, 2020 Stipulates the procedure for constitution of a Selection panel for the purpose of a suitable candidate for appointment of Secretary to the Samburu County Public Service Board.

In accordance with section 58A (1) of the County Government (Amendment) Act, 2020, that provides that there should arise a vacancy in the County Public Service Board, The Governor Shall nominate and, with the approval of the County Assembly, appoint members to a selection panel for the purpose of selecting suitable candidates for appointment as members of County Public Service Board.

The selection panel under subsection (1) shall consist of the following person-

- a) A Chairperson, not being a public officer;
- b) One person from the Private Sector;
- c) And Advocate of the High Court of Kenya, who is a member of the Law Society of Kenya;

- An Accountant who is a member of the Institute of Certified Public Accountants of Kenya; and
- e) One person from an association representing workers,

Following the nomination of the County Public Service Board Selection Panel by H.E the Governor in Accordance with Section 58A (1) of The County Governments (Amendment) Act, 2020, and Pursuant to Section 8(1)(a) of the County Governments Act, 2012, the following persons were nominated;

The nomination of the five persons was conveyed to the Speaker through a letter Ref: CGS/OOG/CPSB/SP/Vol.1/001/24 dated 9<sup>th</sup> January, 2024. The nominee's curriculum vitae and other testimonials were enclosed in the letters.

On 30<sup>th</sup> January, 2024 and in accordance with the Provision of Section 7 (1) of the Public Appointment (County Assemblies Approval) Act, 2017 the Speaker reported the receipt of the notification to the County Assembly the nomination of the County Public Service Board Selection panel nominees. In Accordance with Section 58A (1) of The County Governments (Amendment) Act, 2020, and Pursuant to Section 8 (1 a) of the County Governments Act, 2012 and Standing Order no. 200 (4 f) of County Assembly of Samburu Standing Orders, the names of the nominees were referred to the Committee on Labor, Social Welfare, Justice and Legal Affairs for vetting and reporting to the house within fourteen days.

**Consequently,** and in accordance to Section 7 (4) of Public Appointments (County Assembly Approval) Act, 2017, the Clerk of the County Assembly placed a public notice on  $30^{\text{th}}$  January 2024, inviting the public to submit memoranda by way of written statements on oath (*affidavit*) on the suitability or otherwise of each nominee in accordance with the public Appointments

(County Assembly Approval) Act, 2017. The public notice indicated that the submissions were to be received by Monday 5<sup>th</sup> February 2024 at 5.00 pm.

By close of the submission period, the committee did not receive any memoranda touching on the suitability or otherwise of any nominee. The nominees appeared before the committee as scheduled on **Tuesday 6<sup>th</sup> February**, **2024** for approval hearings in accordance with the provision of the Constitution, County Government Act, 2012, public Appointments (County Assemblies Approval) Act, 2017 and the County Assembly of Samburu Standing orders on their suitability or otherwise for appointment to the Samburu County Service Board Selection panel to recruit the Secretary of the Board.

Pursuant to section 58A(1), (2), (3) of the County Governments Act, 2020 and section 8(1)(a), the committee observed that the following nominees met the integrity threshold; demonstrated knowledge of topical, administrative and technical issues touching on the positions they have been nominated for; and had requisite abilities, academic qualification and professional experience to be approved for appointments;-

**Nominated MCA,** (Hon. Lorunyei Lawrence): Mr. Speaker I start from the beginning that I support the report, it is the excellent report I have ever seen, because of inclusivity following the law of Kenya and the regulation... of the House, Mr. Speaker seeing so, I see the gender being represented here, I have seen the minority being represented here, I have seen the balance in religion being represented here.

Mr. Speaker, in the bracket of others, there are youths, there is people with disability there are women, there are minority but selecting among that bracket, it is okay Mr. Speaker not a must that we select people with disability, it is in that bracket Mr. Speaker, that is how I understand the law, the regulation, that bracket of the youth, women, marginalized and disability, one of them has been appointed Mr. Speaker.

Mr. Speaker, if every division, section, people with disability will be less represented, I hope that the president would have been somebody without disability and its deputy should be a person with disability but because of the bracket of that, a woman...

**Specially Elected MCA**, (Hon. Osman Dube): Point of order Mr. Speaker! Mheshimiwa Spika, Mheshimiwa Lorunyei anasema mambo ya walemavu, Mheshimiwa Spika, sisi tumesoma na mambo kwa sheria watu watano wakiandikwa, lazima mlemavu mmoja. **MCA Nachola Ward**, (Hon. Lorunyei Lawrence): Thank you Mr. Speaker, you would have given the Standing Order say that; he quotes this particular law which says that, it shall or it must appoint a person with disability. What I know is the bracket Mr. Speaker.

Mr. Speaker, that is why I say it is the best because it represents the majority, minority, others and regional balance unlike the previous one, so Mr. Speaker, I say that I support the report. Thank you.

Specially Elected MCA, (Hon. Lenamatiyo Silapia): Point of order Hon. Speaker!

The Speaker, (Mr. Lenamarle Stephen): Hon. Silapia now you can just give your point of order.

**Specially Elected MCA**, (Hon. Lenamatiyo Silapia): Thank you Hon. Speaker, I stand on a point of order for Hon. Lorunyei to clarify on the regional balances because when I look at this report I saw the five names of the selection panel that are going to select the CEO or the secretary of the Samburu Public Service Board but when you look at the names, all of them are from Samburu Central and also the North and the Wamba East sub-county, there is no anybody here. So, Hon. Speaker, let the Hon. Member clarify the issue of the regional balance because I am not seeing it. Thank you, Hon. Speaker.

**The Speaker**, (Mr. Lenamarle Stephen): Hon. Silapia let the chairman clarify and not Hon. Lorunyei. Hon. Leleruk.

**MCA Suguta Ward**, (Hon. Leleruk James): Thank you Mr. Speaker, I must congratulate every Member that is trying to raise an issue, because I think this is the first report that we are bringing and to be it is a balanced one and it should not bring a lot of division because the Members that have been selected to come to the Hon. House are Members of Samburu County. So, if we decide to say that this region is not... and all these Members are Members of Samburu County, I do not know what regional balance do you need, unless there are other parameters that are being used so that we can judge that this is not the correct procedure to be followed.

Again Mr. Speaker, we are following the law, we have followed the law and the people, women and men that are being selected here all of them, I would like the Members to argue on the basis of they are not from that sector because the Governor have tried to balance the people of

Samburu County, how we live in Samburu County but the issue of one sub-county not being represented, I know we are representing Samburu County.

As an MCA of this House or as any Member of the Couty Assembly, we are representing Samburu County, so I do not see the reason why we are bringing the issue of regional balance. Thank you, Mr. Speaker.

**MCA Wamba East Ward**, (Hon. Lelenkeju Jackson): Thank you Hon. Speaker, I stand to second the motion or to support the motion, though I have few reservations here and there. Looking at the list and what Hon. Lorunyei said, that it is a bit balanced because of religion and gender and to my Hon. colleague Dube, I agree that requirement is there but, on the bracket, sometimes when we come to professional qualifications, not anyone wishes to be disabled, that is an act that happens and nobody will be happy about being disabled but at the same time, when we look at professionalism sometimes maybe or the interested people that applied for these jobs.

Sometimes maybe a disabled person failed to apply or even qualify for the position based on the qualifications requirements that are there. On another note, yes, the chair said that the Governor tried to be fair and balance the Samburu people and truly, all the Members here are from Samburu County but as a Member of Samburu East, we are being left in several considerations say for example, County Assembly of Samburu Service Board no one comes from Samburu East among the six Members and again here, it is another serious list and no one is appearing.

We want to send a signal to the concerned parties, that next time you do consider regional balance because that is the only way we can service our people adequately and equitably by making sure that every region though Samburu's or residence of Samburu next time we consider them. Otherwise, Mr. Speaker sir, I support the motion.
