## **COMMUNICATION FROM THE CHAIR**

**Temporary Speaker**, (Hon. Lenamparasio Phelix): Hon. Members, Section 18 of The County Government Act Amendment Act, 2020 stipulates a new procedure in nominating the Chairperson and members of the County Public Service Board. Section 58 (a) of the same Act requires the Governor to nominate and with approval of the County Assembly appoint a selection panel for the purpose of selecting suitable candidates for appointment as the members of the County Assembly Board.

In line with the above, I hereby notify the House that I have received from His Excellency the Governor a list of nominees to serve as the County Public Service Board Selection Panel, the names comprise of the following persons:

1. Mr. Tom Lulosoli – Chairperson
2. Ms. Nasieku Lesoloyia – Member, Private Sector
3. Mr. Thomas Lenakio – Member, Advocate of the High Court of Kenya
4. Ms. Dorcas Lekisanyal – Member, Accountant and Member of ICPAK
5. Mr. William Lengoyiap – Member, Representing workers

## **STATEMENTS**

**Temporary Speaker**, (Hon. Lenamparasio Phelix): Hon. Members, it is notified that the Speaker has approved the following response for today Tuesday 19<sup>th</sup> November, 2024 at 2:30 PM pursuant to Standing Order No.45 (c):

1. Statement No. 042/2024, requested by Hon. Lenamparasio Phelix, MCA; Loosuk Ward to the Chairperson Sectoral Committee on Lands, Physical Planning, Housing and Urban Development regarding the planning and survey of Loosuk town in Samburu County.

Hon. Chair.

**Chairperson Committee on Lands, Physical Planning, Housing and Urban Development,** (Hon. Leerte Patrick): Ahasante Mheshimiwa Spika, nashukuru Kwa kunipatia nafasi, Mheshimiwa Spika kweli hoja ya Hon. Lenamparasio MCA Loosuk Ward ilikuwa ijibiwe lakini nikama idara hajapeana mwelekeo. Mimi mwenyewe na Vice Chair tulienda mpaka ofisi yake na tukaongea na kumweleza kwamba kulikuwa na hoja hilo la mipangilio ya town na akatuahidi atotoa lakini mpaka sasa hajapeana chocote; hata nilipiga simu saa zingine kama saa tano na hakuna mtu alichukua simu. Nilimpigia CO lakini bado Hatujapata jibu kwa hivyo naomba nafasi ili niweze tena kufuatilia Mheshimiwa Spika. Nikitoka hapa nitatafuta namna nyingine tena.

**Temporary Speaker,** (Hon. Lenamparasio Phelix): Asante sana Mheshimiwa Leerte. Hii mambo sasa ni kali kwasababu mimi ndio niliuliza Statement na mimi ndio Spika wa siku. Kama wiki mbili imepita Spika alikuwa amedirect ya kwamba kama hiyo Statement haitakuwa imejibiwa itakuwa ni jukumu ya kamati kuita idara wakuje mbele yenu waseme ni kwanini hawajibi.

Leo mimi kama Spika Mheshimiwa Leerte hatupeani tena siku nyingine mingi; hili Statement liliulizwa tarehe 15 mwezi wa kumi leo ni mwezi wa kumi na tisa mwezi wa kumi na moja imekuwa mwezi moja na siku kama tano na hiyo ni muda ya kutosha sana. Wacha indirect sasa kwamba the next step sasa ni kamati ikiwa mwenyekiti kuita the Department na the CEC of the Department aje ajibi kwa nini hajarudisha hiyo Statement. Mheshimiwa Lorunyei...

**MCA Nachola Ward,** (Hon. Lorunyei Lawrence): Mheshimiwa Spika nafikiria ungetupatia nafasi kidogo tuzungumze hata sisi kabla hujapeana direction na Unajua sasa ukiwa Spika pale lazima uwe neutral kwasababu sasa kwasababu wewe ndio mwenye Statement Unajua ukiwa tena referee Unajua hii conflict of interest uangalie vizuri zaidi. Mheshimiwa Spika kufuatana vile iliulizwa Statement na imechukua muda tunaudhika sisi sote ni kwasababu gani kwasababu tuko kwa kazi na kama unakuja hapa na unakaa bila kazi unakaa ivi ivi tu na unakamata mshahara na umetumwa kufanya kazi sio kitu kizuri.

Sijui ni kazi gani hawa ma CEC wanafanya kwasababu tunapea mtu kazi na hafanyi kazi. Badala ya kujibu swali ako occupied na shughuli zingine na ndio maana hafanyi kazi yake. Hii ni kazi yake ya ofisi na pia kuja mashinani...

**MCA Nachola Ward,** (Hon. Lorunyei Lawrence): Sasa kama yupo ofisini na hamna kazi mashinani, na mtu analipwa mshahara, mtu anawajibika nama gani? Kwa sababu kulingana na laini ya authority ama ya amri. Laini ya amri inatoka kutoka juu kuelekea chini. Laini ya kuwajibika inatoka chini kuelekea juu na sasa watu hawa ambao tumewapa kazi hawapo hata katika ofisi kupokea simu am ahata kutuandikia pale mashinani hatuoni kazi kwa hivyo inaonekana kuna mchezo Bw. Spika mwongozo unasema labda tuchukue hatua nyininge, Nikiongeza nilikuwa nikizungumza na kugombana na CECMs Fulani, alinieleza nyinyi katika Assembly kwani huwa mnafanya kazi gani? Kuna deal gani hata mlifanya? Au kazi gani mlifanya mnatuambia saa hizi ya kwamba mlifanya.

Kwa hivyo, inaonekana kwamba sisi hapa hatufanyi kazi na kunao watu wanaotufanya tuonekane hatufanyi kazi na lazima tuamke tufanye kazi na kama tuanze na hii sasa lazima tuanze tujue kwamba alikuwa wapi, off ya kila siku hata uwe Mombasa, Isiolo, nyumbani (unaudible) kwa mfano Nachola, Marti au Towns katika ukisema maneno ya plots Kaunti tunapata revenue. Iko shida Bw. Spika nakwaaambia hata kama wewe ndiwe mwenye hii Statement, Mwenyekiti wa hiyo Kamati inaonekana analeta urafiki Zaidi, aitwe hapa aseme sababu gani aandike hafanyi kazi hapokei hata simu labda hata tumuelewe ya kwamba hata ye ye attachukue hatua nyiningme asante Bw. Spika.

**Temporary Speaker,** (Hon. Lenamparasio Phelix): Asante sana Bw. Lorunyei kwa maoni yako sijui kama kuna mwingine angependa kutoa maoni ndio niweze kupeana direction. Asante unajua ni kwa sababu ya manufaa ya kila Member, na kwa manufaa ya Mheshimiwa Leerte lakini amekuwa hapa siku hizo zote tarehe ishirini na tisa mwezi wa kumi ilikuwa jumanne, siku hiuyo hii Statement ilikuwa ijibiwe hapa lakini siku hiyo tulikuwa tunaaapisha Mheshimiwa mgeni na ikapelekwa tarehe 30 ambayo ilikuwa jumatano siku iliyofuata, siku hiyo Statement hii haikuwa imejibiwa na Spika wa siku hiyo alikuwa ameelekeza kwa kamati ya kwamba kwa sababu Mheshimiwa, Mwenyekiti aliomba siku saba wakaambiwa ikifika tarehe tano mwezi wa kumi na moja kama Statement hiyo haijaletwa assembly kujibiwa kamnati waandike barua kwa CECM.

Akuje to appear mbele yao aweze kujibu iyo maneno. So unaona kutoka tarehe tano mpaka tena leo, hakuna kitu imefanyika na tunasikia vibaya sana kama Mheshimiwa kama huyu anatembea miguu anaenda mpaka kwa oisi huku kwenda kuuliza CEMC nab ado hawajibu. Mheshimiwa mwenye kiti alisema alienda mwenyewe miguu, naibu yake pia alienda na bado iyo statement wiki tano mpaka sahii haijajibiwa, na vile unasema hawa watu wako tu huku wanakataa kufanya kazi yao mpaka ata wanafanya sisi tena kama hatufanyi kazi yetu.

So mimi tu nataka tu nirudie ile mwelekezo yenyenilipeana, sitarudisha nyum, Mheshimiwa chairman wewe utaandika barua, utaandikia departmeny yako wakuje mble ya kamati yako na baada ya siku kumi nan ne, utakuwa umelete iyo ripoti kwa hii nyumba kwa sababu tukiendelea hivi wale wengine wataona tu ni kazi ya kawaida. Statement itakuwa inauliza na hakuna mwenye atakuwa anajibu so wacha nielekeze hivo sijui kama kuna mwenye ako na maoni yeoyote?

**MCA Poro Ward,** (Hon. Leerte Patrick): Mheshimiwa sina maoni ingine yale mheshimiwa Lorunyei alisema ni kweli, wacha nichukuwe iyo jukumu kwamba nitaandika barua alafu CEMC na kamati yake waweze kuja mbele ya kamati alafu ziweze kuulizwa moja mbili watueleze kwa sababu gani sumu hawachukui na statement hawaleti. So nitaandika barua Mheshimiwa Spika.

**Temporary Speaker,** (Hon. Lenamparasio Phelix): So ni mzuri ujue Ya kwamba iyo siku kumi na nne itaisha tarehe 2/12/2024 juu tunaenda recess tarehe tano.

**MCA Poro Ward,** (Hon. Leerte Patrick ): Sawa Mheshimiwa Spika.

**Temporary Speaker,** (Hon. Lenamparasio Phelix): Asante. Mheshimiwa Lorunyei?

**MCA Nachola Ward,** (Lorunyei Lawrence): Mr. Speaker, there was a statement asked to the Chairperson concerning the status of water of many boreholes in Nachola and we are going to recess, we come after recess I do not know whether the clerks have been tracking, so Mr. Speaker I would like your directions. Thank you.

**Temporary Speaker,** (Hon. Lenamparasio Phelix): Was it responded to?

**MCA Nachola Ward,** (Hon. Lorunyei Lawrence): It was not responded to up to these minutes.

**Temporary Speaker,** (Hon. Lenamparasio Phelix): Okay. So I think Hon. Leleruk is a member to that committee.

**MCA Suguta Ward**, (Hon. Leleruk James): Mr. Speaker, Chairman is in the PIC ns PAC committee but he has instructed me to work if the statement was brought to this House but up to now I have not seen it, so we are ready to respond if the statement is with us. He was hoping that the statement was to be brought today but unfortunately it is not in the order paper.

**Temporary Speaker**, (Hon. Lenamparasio Phelix): So was it the same statement that we requested with you?

**MCA Nachola Ward**, (Hon. Lorunyei Lawrence): I think so, it was a respond.

**Temporary Speaker**, (Hon. Lenamparasio Phelix): I am asking on 15<sup>th</sup> October, you requested a statement, so is it the same statement that was not responded to?

**MCA Nachola Ward**, (Hon. Lorunyei Lawrence): Yes.

**Temporary Speaker**, (Hon. Lenamparasio Phelix): Okay. So I think let me direct that the Hon. Leleruk because the Chair on water is as well the Chair of PIC band PAC.
