LOOSUK TOWN URBAN PLANNING

The Speaker, (Mr. Lenamarle Stephen): Hon. Members, it is notified that the Speaker has approved the following request for statements today Tuesday, March 4th, 2025 at 9:30 AM pursuant to Standing Order No. 45 (c):

Statement No. 002/2025 requested by Hon. Lenamparasio Phelix, MCA; Loosuk Ward, to the Chairperson Committee on Lands, Physical Planning, Housing and Urban Development regarding the Loosuk town urban planning

MCA, Loosuk Ward, (Hon. Lenamparasio Phelix): Hon. Speaker, Pursuant to Standing Orders 45 (c), I hereby request for a statement from the Chairperson Committee on Lands, Physical Planning, Housing and Urban Development regarding Loosuk Town urban planning.

Hon. Speaker, chapter 5 part 1 (60) of our Constitution describes the principles and policy that manage our land; equitable access to land, security of land rights, sustainable and productive management of land resources, transparent and cost-effective administration of land, sound conservation and protection of ecologically sensitive areas.

Hon. Speaker, according to section 14 (1) of the Urban and Cities Act, in the statement the Chairperson should inquire into and report on:

- 1. How many plots are in Loosuk Town? Clearly classify the commercial, residential and public utilities
- 2. What is the status of Loosuk Town Planning up to now?

Hon. Speaker, there are other Members who also want to know the planning status of their towns. I suggest that when the Clerk drafts a letter to the Department, towns such as Porro, Archer's Post and Kisima

- 3. Clarify the procedure of allocating plots in Loosuk town and who is allocating the plots?
- 4. If the County Executive Committee Member is aware of the encroachment of Loosuk dam and Loosuk Amani stadium parcel? Who allocated plots in the said parcels?
