COMMUNICATION FROM THE CHAIR

The Speaker, (Mr. Lenamarle Stephen): Hon. Members, Pursuant to the Provision of section 13 (1) (a) of The Samburu County Community Conservancies Fund Act, 2019 as amended in 2021 and read together with section 4 and 6 of the Public Appointments County Assemblies Approval Act Cap. 265 (b), I wish to report to the County Assembly that a message has been received from His Excellency The Governor, nominating Mr. Joseph Partamei Lepariyio for appointment as Chairperson for Samburu County Community Conservancies Fund Board.

The nomination was conveyed through a letter dated 24th March, 2025 Reference No. CGS/CA/APPT/VOL.3/009/30 and was received at the office of the Clerk on 25th March, 2025.

The name submitted for vetting and approval is Mr. Joseph Partamei Lepariyio, the position is Chairperson Samburu County Community Conservancies Fund Board.

In line with section 7 (1) of Public Appointments County Assemblies Approval Act, 2017 and to facilitate the vetting process I hereby direct as follows:

- 1. That the office of the clerk to conduct a preliminary compliance check to established advisability cause notification for public participations and hearing within 7 days.
- 2. That the nomination is committed to the sectorial committee of tourism, trade, enterprise development and cooperative for vetting and tabling of the Report within the prescribed timeframe. The committee shall consider the procedure used to arrive at the nominee and the shortlisted criteria, any legal or constitutional requirement relevant to the office and the nominees suitability, qualifications and the experiences for the position. Let the committee and Members treat this matter with agency it deserves. I thank you.

Specially Elected MCA, (Hon. Lenolkulal Esther.): Asanmte sana Mheshimiwa Spika. Nachukua fursa hii kumshukuru Mungu. Naomba kusoma statement yangu. Kwa mujibu wa kanuni wa kudumu 45 1(c) naomba kauli kwa mwenye kiti wa kamati wa sekta ya kaszi ya ustawi wa jamii na hahaki za kisheria kuhusu waajiri ya walimu ya maendeleo ya watoto ya awali ECDE.

Kwa kuelewa kwamba msingi wa Elimu bora kuanzia elimu ya utoto awali tunpojitahidi kwa uatikanaji kwa elimu kwa wote , ni muhimu kama mcheketo wa uajiri iwe wazi kuhakikisha kuwa walimu waliohitimu wanapewa fursa ya kuchangia katika elimu ya watoto wetu wadogo. MCA Loosuk Ward, (Hon. Lenamparasio Phelix): Thank you Hon. Speaker. But the funniest thing here is that, I think the House Business Committee are only working...

Mr. Speaker, (Hon. Lenamarle Stephen): Let us stop at that, we cannot discuss it. Just take your seat. Sergeant-At-Arms, I want to make an Order of this House, Hon. Lenamparasio walk out and you will be out for 4 sitting days. That is my Order. Just get out. Sergeant at Arms...

MCA Loosuk Ward, (Hon. Lenamparasio Phelix): I am not moving out. I was elected by Loosuk people and you come from Ndoto. You never elected me! I am not moving! So, anybody here should go and bring police or any other thing. I am not appointed.

Specially Elected, (Lenamatiyio Silapia): Bwana Spika tunaomba kwa heshima tafadhali ...

Mr. Speaker, (Hon. Lenamarle Stephen): I think I am done with that. Hon. Lenaparasio should be out. We cannot move on. Hon. Lenamparasio I want you out kindly. So that we can continue with the business of the House.

MCA Loosuk Ward, (Hon. Lenamparasio Phelix): I withdraw and apologize.

Mr. Speaker, (Hon. Lenamarle Stephen): Hon. Members apology accepted. He has withdrew. Just withdraw that from the Hansard. And I want Members to know that this is a House of rules and therefore we must follow them.
