## **COMMUNICATION FROM THE CHAIR**

**The Speaker,** (Mr Lenamarle Stephen): Hon. Members I would like to acknowledge the presence of visiting students and teachers from Lolmolog mixed secondary school in Suguta ward Samburu west sub-county in our public gallery today. In our usual tradition of receiving and welcoming visitors to the assembly I extend warm welcome to them on behalf of the County assembly of Samburu and I, I wish them a fruitful visit. Thank you.

Since the MCA Suguta ward is out on official duty, I welcome Hon. Lenamparasio as the neighbour to welcome the students

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): Thank you so much Hon. Speaker. On behalf of my brother Hon. James Leleruk and I, I would like to take this opportunity to welcome our students and teachers from Lolmolog mix to this assembly. These are our daughters, sons and brothers. I know in high school there's a subject by the name history and government so most of the things they'll see here are normally taught in schools. There is a lot of difference between teaching and coming to see for them.

I know today they will learn a lot especially on how we conduct our business here and I want to welcome them. They should feel free. Among them we have MCAs MPs Governors and Presidents. In future God will open doors for you and you may find yourselves elected to serve in different capacities. Loosuk and Suguta ward border each other especially Loolmolog Mix. I have a number of students from my ward schooling there, the teachers sitting there are from my ward so I am so proud to see them here. Feel free and enjoy yourselves. Thank you.

**The Speaker,** (Mr Lenamarle Stephen): Hon. members it is notified that the following statements are response to members general statements on topical issues is due for response today Wednesday 28<sup>th</sup> May 2025 at 2:30 p.m. Person to standing order 51(B) and standing order 53(1,2 and 3) respectfully. Number one statement request from the Chairperson of the committee on education and vocational training in regards to the status of Lmarei ECD school in Loosuk ward.

Hon. Lorunyei.

**MCA Nachola Ward**, (Hon. Lorunyei Lawrence ): Thank you Hon. Speaker. Before the response for the statement thought I would like to extend the welcoming the school from Suguta ward. I am a teacher by profession and I would like to the children that when you to school, you get knowledge and skills for safe employment and where your service will be required. Focus on getting knowledge and skills to create self-employment. That is why CBC is focusing on it. When you complete studies and get certification, you need to go ahead to higher institutions for skills. When you leave with certificate only you won't go anywhere.

As the Hon. Member for Loosuk ward said there are future leaders there, the MCAs, but the MCAs elected in Samburu County are just 15. It is impossible for all of you to be MCAs the MPs are only three and one Governor. It is important for you to focus on improving yourself. I wish to respond to the request of statement of Hon. Lenamparasio MCA Loosuk ward regarding a teacher in Lmari ECD. The question on why there is no teacher in Lmari ECD from first term of the year 2025.

The answer given by the department is that this is a common problem in most wards and the department posted a teacher after carrying out teachers' distribution recruitment and balancing. I am reading it as it is. The second question was is the department aware that Lmari pre-school is closed due to lack of ECD teacher. The answer given is no the department was not informed but we have got the information through this MEMO and action has been taken. Meanwhile the centre has volunteer teachers therefore learning never stops.

We hope to observe them when the next budget is allocated and recruitment happening. Those were volunteering. The third question asked is, is the department aware that Lmari ECD teacher retired and there is no replacement up to date. The answer given is that, yes we are aware and the replacement done and the teacher posted is expected to report to the centre with immediate effect. I asked for the teacher's names and was told the name is Madam Elizabeth Lekopole. We have got a problem in education department.

We have 562 ECD centres and according to the database, the teachers we have for ECDs are 207 meaning there are many ECD centres without teachers. Action needs to be taken and more money to be allocated to education so that it can have money to employing more teachers. Imagine 562 ECDs and the county has employed only 207 teachers so we have crisis. I would like to stop there without creating more arguments. Thank you.

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): Thank you so much Hon. Speaker. Let me take this opportunity to thank my senior the education Chair for reading this response. I just have one or two reservations regarding these statements and they are very serious. When I did these statements, I had three questions. I am not certain if they are answered appropriately. Let me say that Lmari ECD has been there since devolution and it had a teacher employed by the county government.

By November 2024 the teacher retired having reached retirement age as per the public provisions and there was recruitment of teachers by the county government's public service board. Interviews and selection of successful candidates was done. There whole of first term of 2025, Lmari ECD had no replacement for the teacher who retired despite the teacher's recruitment. Lmari ECD is in my ward and I'm so conversant with my ward more than any other person, department of education and public service board.

During first term the parents saw the need of having a volunteer and there was some mutual agreement with the parents and that volunteer that each kid should pay 50 shillings to cater for some incentives for this volunteer. Before I did this statement I went to the department of education six times regarding the same issue immediately after the listing of the successful ECD teachers. It was unofficial since I left home to go to that department. Every time I went there, I raised the need of having replacement of that teacher.

It was never done up to today. I don't work in the department of education. I am not supposed to be the one reporting to them that there is no teacher in that school. I know since I was once a CEO for education that there was some people in that department who were supposed to be monitoring what is going on in these ECDs. I think they are quality assurance officers and we have one on my ward. I am doing his job because I am the one who knew that this school is closed since there is no teacher.

It is so unfortunate that the department is saying that they are not aware of Lmari since the opening of second term, no kid has reported. On 19<sup>th</sup> may I personally took the initiative and went to that school and found it deserted with padlocks everywhere and I couldn't see any sign of pupils around that school because since the end of first term the agreement between the volunteer and parents never materialised. Most parents didn't pay the 50 shillings and the volunteer quit to find another hustle.

She even called to inform me that she stopped going to that school since the parents aren't paying her. From the third question that the Hon. Chair has read of the department saying that they have posted a teacher by the name Elizabeth Lekopole, she teaches Lmisigiyoi primary. It is just an adjacent ECD centre. I'll be quiet today because these guys are solving a problem by creating another.

I know tomorrow or next week, Lmisigiyoi primary will be closed because there will be no teacher. I don't know if by the way executive always waits for us to do statements to act. What could have happened if I have never done this statement, Elizabeth would not have been posted to Lmari because I have gone there six times without a statement and nothing was done. Just because I did a statement last week, they are rushing to remove a teacher from another school, making me a fool to take that teacher to Lmari so that next week I will be having another statement here of Lmisigiyoi ECD centre.

As much I concur with my Hon. senior that we have many ECD centres without teachers, it is so unfortunate that the third budget I have seen in this house, there was no single budget from the department of education on recruitment of ECD teachers. The 24/25 budget that went for public participation, that was the biggest public cry that we need ECD teachers because we have many ECD centres with no teachers.

ECD is where our education starts and if we get wrong from it we will be messing with the entire education of our kids as they advance to secondary and tertiary level. That is where we should get very strong foundation for every kid in our county. Let me say thank you Hon. Chair. Tomorrow I will go check if Elizabeth Lekopole has reported to Lmari so that we have a meeting asking parents to bring back their kids.

You know the executive is giving the MCAs a lot of rough time because whenever there is no teacher in that school parents will come to me asking for a teacher. Since the school is closed it is my work again to go and create a meeting telling people that the ECD teacher is back for them to bring their kids which is not supposed to be my work. I think the education Chair these quality assurance officers should do their work checking these ECD centres.

We know that the ECD centres that have teachers are same as the ones that don't have teachers because nobody is following on these ECD teachers, supervising or doing monitoring and

evaluation. Most our ECD teachers nowadays are boda boda riders in towns because they are employed get a payslip, get a loan, buy a pikipiki and go to the stage because nobody will follow if these teachers go to school or not so they are their own bosses.

They go to school if they wish and if they do not, they go to stage to get some hundred or two hundred shillings. I think we have a lot to do with the department of education and as this house we will always prioritise the employment of ECD teachers across our county because that is where the foundation of education for our kids starts. Thank you.

**Specially Elected Member,** (Hon. Lekirenyei Sarah): Asanti Mheshimiwa Speaker. Kwanza kabisa ningependa kuchukua nafasi hii kwa njia ya kipekee kukaribisha watoto wetu kutoka Lolmolog primary school. Wajiskie wako nyumbani hili ni bunge lao...

**The Speaker,** (Mr Lenamarle Stephen): Order Hon. Sara watoto wametoka Lolmolog mixed secondary school sio primary.

**Specially Elected Member,** (Hon. Lekirenyei Sarah): Sorry Mheshimiwa Speaker. Watoto wetu kutoka Lolmolog secondary school mjiskie mko nyumbani. Hili ni bunge lenu na mjiskie mko huru. Nikijaribu kufuatilie mambo ya education leo tumekua department ya education hapa na tumejaribu kama kamati kuzungumzia yale yanatukomba sisi kama wards. Mheshimiwa Lenamparasio analalamika sana kuhusu mwalimu na vile department wameketi chini wakaamua kutoa huyo mwalimu kwa sababu hakuna haja ya walimu kukaa wakiwa wengi shule moja na ingine haina.

Tunaona kwamba county yetu saa hii iko chini na hatuna budget kama department ya education ya kuweza kuajiri walimu wengine. Last week jumanne tuliona wale walimu waliofanyiwa replacement walikua kumi na nane. Shule moja unaezapata walimu wane wanafanyiwa replacement na hakuna mtu anakubali replacement ifanywe mahali hakuna walimu.

Nafikiri hiyo ndio ilikua shida ndio maana huyo mwalimu hajakua replaced na wards zingine zimepata haki yao. Tungependa kuambia Mheshimiwa department wanangangana na pia hiyo shule ambayo wametoa huyo mwalimu watatfuta mwengine wa kumreplace. Asanti.

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): Mheshimiwa Speaker nataka kuambia vice Chair wa education kwamba wakati walimu walikua wanaajiriwa kwa ECD, ata kwa ward yangu

kuna wenye walikua wameenda retire. Wakati hawa walimu walijajiwa pia mimimkwa Loosuk walipeana walimu wane kwa ward. Mimi nilikua nauliza kama mwalimu alienda retire na walipeana walimu wanne kwa Loosuk ward kwa nini wasipee kwanza priority ile shule yenye mwalimu anaenda retire. Asanti.

**Chairperson Education and Vocational Training,** (Hon. Lorunyei Lawrence ): Mr Speaker I thought that we have put this thing to rest because the question was about Lmari ECD and a teacher has been posted there. Thank you.

**The Speaker,** (Mr Lenamarle Stephen): Thank you Chair. Hon. Lenamparasio you pass by tomorrow to check if there is a teacher at Lmari ECD and Lmisigiyoi. The teachers must be in the two schools. If one of them is missing you report to this house so that we can take action.

Statement number 2. Statement requested from the Chairperson of the committee on lands physical planning housing and urban development regarding the Loosuk town urban planning.

**Specially Elected Member,** (Hon. Lenolkulal Esther): Thank you Hon. Speaker. Maneno ya hii statement pia tuliongelelea asubuhi na tumeona kwa sababu tulirekebisha standing orders zetu. Tungependa CEC wa lands aje ajibu maswali kwa sababu tunamwita na hakuji pia hatupe response. Tunataka CEC aje kwa house kujibu maswali kwa sababu pia kuna statement imekaa sana ya Nasur. Thank you.

**The Speaker,** (Mr Lenamarle Stephen): Asanti sana Hon. Esther. Nafikiri the issue of Loosuk has been sorted. We have discussed it for a very long time in this house. There was a time we said that we are going to invite the CEC. Hon. Lorunyei, I want to give out direction. Yes...

**MCA Nachola Ward,** (Hon. Lorunyei Lawrence): Mr Speaker if I can go to the standing order of the revised county assembly of Samburu standing order (52) and it reads non-attendance by executive committee member. As I read that the county assembly may where the county executive committee fails without reasonable cause to appear and respond to questions under this part, move a motion to censor the county executive member.

When you give an executive a chance and he fail, there is always a second chance and it is this one am going to the standing order of **The County Assembly of Samburu**, thank you.

**Specially elected Member,** (Hon. Lenamatiyo Silapia): Thank you Hon. Speaker, let me take this opportunity to welcome the students from Lomolo mix secondary school, you are welcome to this house and feel at home. Let me also raise my concern on the same statement and on the same department. It has been a culture of that department by taking so long to respond or answer the statement raised by the Hon. Members of this house.

You know Hon. Speaker, you really remember the statement sorted by the Hon member for Suguta Mar Mar ward, the issue of Nassur. Up to today we have never got a respond of that, then again today we have a statement sorted by the Hon. Member for Loosuk ward. It is now taking like six months without a respond and also the CEC fails to appear before this house. Hon. Speaker the class has sent the letter to the CEC to appear before this house on 9<sup>th</sup> April. Today we are in 28<sup>th</sup> May, what does this show?

So, with your leaders, supported by our standing orders, as read by Hon. Lorunyei. If they fail to appear, then we have other mechanism way or other ways of solving such problems because it seems like the CEC is undermining the role of the assembly. It has also denied the people of Loosuk those services to know the plans on their town (Loosuk town). So, with your guidance, with your leadership; please Hon. Speaker it has been long overdue for this house to be discussing every day to say let the CEC appear and he is not adhering, he is there writing letters to us and he is busy campaigning in town. So, with your guidance please lead this house.

**Specially elected Member,** (Hon. Lenokulal Esther): asante mheshimiwa spika, naomba msamaha kwa sababu nilisahau kuwakaribisha wanafunzi, nachukua fursa hii kuwakaribisha wanafunzi wa shule ya secondary ya Lomolo. Karibuni na mjiskie mko huru. Na mheshimiwa spika nikiongezea nafikiri pia sisi hii department imetufika kwa koo , kwa hivyo tunakuomba mheshimiwa speaker yale maelekezo utachukua leo ikuwe ya mwisho kwa hii department, mheshimiwa spika kwa sababu tumeshoka kabiza. Asante.

**Specially Elected Member,** (Hon. Lekirenyei Sarah): asante mheshimiwa spika, ningependa tu kuongezea kusema kua mambo ya mchanga imekua ngumu sana katika kaunti yetu ya Samburu. Imekua kilio kila mahali, Samburu east, Samburu central na Samburu north. Ukijaribu kuangalia kuna hii shamba inaitwa Lomotio farm ambayo ndo ngombe yetu ya county ndo wanawekwa ili wawese kula nyasi na kunini hapo. Hata ukiangalia haijakuwa bicon ni ile tu imefenziwa kwa



chanjo lakini haijakua bicon. Ukijaribu kuangalia town yetu ya Baragoi watu wanapigana bado wanapigana, tusema sahisi ni mwaka tatu wakiendelea kumsumbua MCA. Hadi saa hii bado haijasolfiwa hiyo shida mheshimiwa spika. Hii imekuwa too much mheshimiwa Speaker. Asante.

**MCA Loosuk ward**, (Hon. Phelix Lenamparasio): Thank you so much Hon. Speaker, I think am the one who sorted this statement and thank you so much Hon. Members for supporting this. I think you know I had a reason or the people also get the reason as to why we are supposed to ask these questions for the department. You know that this statement has been in this house for quite some time. I think in the budget of this financial year **2025/2026** was step hold in this house.

The reason why I wanted to be told the status of Loosuk town is because I had reservations on development in that town on the financial year **2025/2026**. Hon. Speaker I know you have gone abroad there .you know to me personally as a member of Loosuk, I wanted to allocate some money to do all roads in that town, every road. The second thing, there was a water that I drilled by ward fund in Loosuk hospital. I wanted that water to be extended to a number of plots in that town.

You cannot do if you don't know the status of planning in that town. You can maybe do some extension of water through somebody's plot and they can take you to court. I just wanted to have that ward book, which will help me follow where the water ways should pass or the roads should supposed to be. I had promised youths during the last year MCA cup that I will build them a stadium (Amani stadium). There is no way I can allocate money for that stadium if I don't know where point A, B, C and D of that stadium is.

You know that this statement is even denying the people of Loosuk a lot of development that am ready to do myself as their member. On 2<sup>nd</sup> May this year I was ask by a clerk to go and follow our revised standing orders to do another statement so that the CEC to be called and appear before the whole house, I wish I did. The CEC received that letter on 3<sup>rd</sup> April, funny enough Hon. Speaker on 8<sup>th</sup> April at 5pm I was in this house the CEC brought a letter requesting for postponement to appear before this house and it was you who directed the CEC should appear before this house on 9th April, not before the committee or before me but all of this house.

Hon. Speaker if this CEC, s and the executives continuous taking this house for granted to me I am seeing it is us the members who are so lined to these guys. I want to read out the standing order of article 62, that we should not even be building on asking this guys to come and appear before us a number of times. You can just imagine from 9<sup>th</sup> April to today, how many sessions were there? There are numbers of sessions almost 3 or 4 sessions or attendance 3 or 4 weeks. So Hon. Speaker with your guidance, to me if was today visiting that page, I could just direct we do access the motion and so because nobody in this case could come and appear before us, we didn't if you give another direction maybe next week they should come and be here or they will not even likely to appear. We are very ready here to access the motion because people of Loosuk want services. Thank you

**The Speaker**, (Mr. Lenamarle Stephen): Thank you Hon. Members, Hon. members I gave all the directions and the CEC requested that there was a recess and all that, but I want to give out another direction today, that members to sit down and; put all away the questions that pertains lands not only the Loosuk land, all the lands within the country, all the questions. The CEC to receive the letter tomorrow and he will appear here on next week Wednesday 2:30pm to answer all the questions in that letter and let him appear here next week Wednesday and if he fails then we go to what Hon. Lorunyei ...''.

So let that one be final and the CEC should receive the letter tomorrow, am requesting the tracker system. Let us put all the questions even the Nassur, all that should appear in that letter so that the CEC will answer all those questions. So, all the members that have questions concerning the land to forward their questions to the tracker system as soon as possible to be compiled and then the CEC receive all. Hon. Lorunyei.

**MCA Nachola Ward**, (Hon. Lorunyei Sebastian Lawrence): Mr. Speaker there is the difference between to center and to impeach. When you call somebody is to center, you are calling him to inquire if he knows his work and impeachment is the state you penalize one by removing that person from the office, for your information. Thank you.

**The Speaker**, (Mr. Lenamarle Stephen): Thank you. What we are doing is, we are inviting the CEC, but to center is to summon. So if he fails next week, we summon and if he fails the other one we impeach.

**Statement No.3;**

The statement request from the chairperson on **Environment, Water and Natural Resources** with regards to water projects in Nachola ward, Hon. Lemartile.

**MCA Wamba West Ward**, (Hon. Lemartile Francis): Thank you Hon .Speaker may also take this chance to welcome our students from Lomolo mix secondary school. Feel most welcome to this sessions and this house. The pending response from the Hon. Member of Nachola, I think we have return that response twice, that it was insufficient to the Hon. Member who sorted the information and as a water committee who wrote the first letter to the department to come and appear before the committee which is on April but they have written some responses that they will not be available almost twice so by tomorrow we will have our third invitation of them, they will appear before the water committee the agenda will be among the statement and the status of **2022/2023** projects and **2024/2025** projects.

So, I just call or invite the Hon. Member because they will appear tomorrow to answer those questions why are they not giving satisfactory information on the projects. So, Mr. Speaker I think that is one procedural way as a committee we have given them the last chance. They have our third invite in case they fail the committee will take another direction of summoning the department to come by force. Thank you, Hon. Speaker that is the starts of the committee.

**The Speaker**, (Mr. Lenamarle Stephen): Hon. Lemartile once the statement is in this house it becomes a property of the house not of Hon. Lorunyei. So, I urge you just get a report tomorrow and then you present to this house next week on Tuesday at 2:30pm. Hon. Lorunyei.

**MCA Nachola ward**, (Hon. Lorunyei Lawrence): Mr. Speaker being a member of Nachola ward we have a problem in this county of water and to try to reduce the suffering of the people, we allocate their money for water. Mr. Speaker Loshoton borehole, you know that we voted to this Hon. House about Loshoton borehole and Ngilati, where about I shoot down the budget because of this borehole and then it was not included in the budget. The reason to our giving is that there is no water in that area.

And then when the constructor went there, because it was given a contract, it was drilled and by God's grace the water was found that there is no any borehole which has water that much in the

Baragoi area. Mr. Speaker everybody was very happy but to the surprise that the contractor I don't know what happen removed all the pipes I don't know because of payment or because of the disagreement of the constructor and I know that by now Lesen, the hole has collapsed as you know that when the pipes are removed the hole will collapse Mr. speaker and to add more insult the constructor was paid and the constructor was Loijuk Lemite and paid through the voucher number 2589 NPO/ASO No.114 invoice No.67 next pay. He was paid about five million, one hundred and five thousand, six hundred and thirty four Mr. Speaker and I am here to give the evidence to this order Mr. Speaker.

I don't know what to say, when you go to Loshooto, they go seventy kilometers to get water, Suguta valley or Nachola Lesen that laga or Karikati and I took the initiative of just the government looking water for this people. So, the department or our CCs are failing the government. You see the bitterness I have and we thought many times about the statement and it is high time that measures to be taken so that we come to conclusion. Thank you.

**The Speaker**, (Mr. Lenamarle Stephen): So, Hon. Lorunyei the chair has already invited you to the meeting tomorrow, but we still want the report in this house about the water in Nachola ward especially Loshooto next week that is Tuesday at 2:30pm. Hon. Chairman is that okay?

**MCA Wamba West Ward** , (Hon. Lemartile Francis): It is an order Hon. Speaker, I think Hon. Member seem to have more information. So, let the department come and confirm that by tomorrow by 10:00 am.

#### **Statement No.4;**

The statement request from the chairperson of the committee on **Public Works, Roads and Transport** in regards to the road status in Porro ward. Who is the member for roads? Who has that respond? Hon. Lenamparasio.

**MCA Loosuk ward**, (Hon. Lenamparasio Phelix): Thank you so much Hon. Speaker. I have a response here dated **21/05/2025**, and am a member of the committee the chairperson and vice chair are all absent. I think am the only other member present here and Hon. Silapia. So, Hon. Speaker let me just read the way it is.

So response to County Assembly Committee on roads, this response is dated **21/05/2025** by **CEC Roads and Transport** (Rose N. Lekalesoi). There is a table here, with the item number, query and response. The Vice Chair is here but let me continue reading. So, implementation and status of Loshumu and Porro road. I remember Hon. Esther asking about this road. The reasons for the department are as follows: On the implementation of Loshumu, Porro road are as follows it has 3 bullets.

- On 19<sup>th</sup> May, 2025 The road was inspected as per the resolution that was taken by the County Assembly Committee members of road, transport and public works. The following team was present:  
MCA representative, Area MCA, Roads department Representative and Village Committee members.
- From the inspection it was resolved the road was done as per the specification of the deal of quantity however potholes have started to develop that require maintenance and repair due to heavy rains and road traffic. Maintenance and repair will be done once the funds will be available.
- The project scope was grading, sports graveling and concrete drift. The gravel of the whole road was not possible due to the amount of funds that was allocated to it hence the sport graveling to the dire session of the roads.

The second item to implementation status of Lodungoro road

- The road was reallocated to Porro sawan, seketet misigiyioy road and done per specification and deal of quantities. The reason for reallocation was due to land dispute issue at Lodung'oro area. The land dispute still stands up to date and it will be dissolved in a stakeholder meeting to be planned. So, Hon. that is the response.

**Specially Elected Member** , (Hon. Lenolkulal Esther): Thank you Hon. Speaker. Wakati nilikua njiani kuenda nyumbani baada ya session ya asubuhi, nilisikia hii respond iko hapa. Na wakati nilifika sahisi niliulizana kwasababu ni kama haikua inawekwa kwa order paper mheshimiwa spika, sijui? Na statement yangu ilikua Lodungoro, Nasiambu na Malaso. Na siku ile department walikuja hapa kwasababu sikua nilimwaambia MCA wangu asikie vile wanasema na nafikiri MCA aliongeza Loshumuni road kwasababu haikua imefanywa vizuri.

Na sikubaliani hata kidogo na hii respond. Ukiangalia kama Lodungoro ilikua kwa private land, kwanini ilipeanwa kandarasi? Na kwanini ililipwa? Nakumbuka wakati ile ingine niliulizana hii maneno ya hizi barabara mbili. Seketet pia ilikua imefanywa na imelipwa. Kwa hivyo, nina changaa kwanini hii barabara ya Lodungoro imewezeje kwenda tena kwa Seketet na Seketet pia ilikua na budget yake na ilisemakana ililipwa kwa ripoti yao.

Kwa hivyo pia MCA ameniambia walienda kuanagalia hiyo barabara. Alienda kuonyeshana kua haijafanyika. Na pia ninataka majina ya hao wanakijiji ama hao committees ambao wamekaa kwasababu Lodungoro ilisemakana ni private nafikiri Porro mzima ni private kwasababu huku mashamba yetu wakati mimi nilikuja 35years ago ilikua mashamba ya watu na pia kulikua na mabarabara. Na mimi pia niko na shamba lodungoro, kwa hivyo sijui hao akina kijiji ni nani? Pia mimi ningehusishwa.

Na pia najua hiyo barabara ilikua inainyongwa inafika hapo mbele ya former governor kitambo na kwanini haikua imekua private land tangu siku hiyo. Na kama ni private land kawnini ililipwa? Ilisemakana ilifanyika 100% na naona hiyo kampuni imelipwa. Kwa hivyo, ninataka majibu vizuri ama huyo surveyor naskia amepelekwa huku eti wenyewe wamekataa anipee majian ya wenyewe ni akina nani wamekataa, ni wangapi ndo nijue. Hapa ni kama tunachezea vitu ya wasamburu.

Na pia kwa statement sijajibiwa Malazo, Baragoi junction Malazo road ambaye pia nilikua nimeuliza na ilikua imelipwa na haikua imefanyika. Kwa hivyo, hizi nusu nusu sijakubaliana hata kidogo. Kwa hivyo nataka respond na watu wa Porro wapate haki yao. Hiyo kidogo ndo sisi pia tunapata. Hakuana kazi nyingi tunafanyiwa na county. Hizo barabara mbili ikkipotea, hizo milioni nane ikipotea siwezi kubaliana na hao hata dakiaka na nusu. Na nitasimama hapa leo na kesho kutetea hiyo haki ipatikane ya watu ya Porro.

Na nilisema huyo engineer alienda hapo nataka kuonana na yeye kwa macho na pia huyo surveyor asimame mbele yangu na kuniambia huku ni private land kwa nani? Kwa hivyo sijakubaliana, na kitu ya kwanza na hizo nusu nusu sijui; mimi ndo nilileta statement. Na mbona sijaitwa kua kuja kwa hiyo barabara tuko hapo. Sijakubaliana hata kidogo kwa hivyo wanipee respond na wapee watu ya Porro respond yao. Asanti.

**Specially elected Member** , (Hon. Osman Dube): Asanti sana meshimiwa speaker. Member wetu wa road, pole sana nimekuashughuli kidogo nikikimbia mahali mkutano na nikasema acha nirudi. Mheshimiwa Esther tulikua hapa kwa hii nyumba, tukakutana tukaita MCA. Area MCA na chairman yangu Lemoso nah ii department wakaenda wakakubaliana. Kwahivyo, vile mheshimiwa Esther alisema mimi sijakubaliana na sisi kama kazi ya kamati tumemaliza. Sasa ninaomba tu mwelekeo kwasababu sisi tumemaliza kazi yetu pahali tumefikisha na tunataka bande yako unasemaje kwasababu tumemaliza kazi.

Ile inasemakana kwa Porro ni shamba la mtu ya Lemeteki barabara inaingia. Mzee akiwa uhai aliuzia watu wengi, kezi mingi sana barabara imeingia ndani sasa community huku wakakubaliana wakasema hii kitu haiwesi endelea. Hii ingine amepeleka Seketet sisi tunajua lakini ile project ingine sisi hatujaona mheshimiwa Esther kwahivyo, utatufahamisha sisi ni budget gani imefanyiwa huku alafu ingine haikuwekwa sisi kama kamati utueleweshe vizuri sana.

**The Speaker**, (Mr. Lenamarle Stephen): Hon. Dube niko na swali, hii barabara ya Baragoi junction naona haijaandikwa hapa na ilikuwa kwa statement, utaweza kutuambia tu...

**Specially Elected Member**, (Hon. Osman Dube): Mheshimiwa Spika, tunaanza Statement ya kwanza ambayo Mheshimiwa Esther ameuliza. Hiyo nyingine tutaingalia kama Statement iko na imefika wapi?

**MCA Wamba West**, (Hon. Lemartile Francis): Hon. Speaker I think by today morning we sat here and the session speaker directed the Clerks to go and write down the pending and not responded Statements. So, most of the Statement we are tasking the Chairs but we have nothing out of it. It is for us as Chairs to give direction of follow up of these Statements so that we know where they are and put up a day for response. Instead of tasking Hon. Chairs because we do not have most of the Statement responses by now.

**Mr. Speaker**, (Hon. Lenamarle Stephen): Hon. Lemartile we have the response for this one.

**Specially Elected Member** , (Hon. Lenolkulal Esther): Asante Mheshimiwa Spika. Wakati ule niliulizia hiyo Statement sikuuliza swali moja vile Mheshimiwa anasema wamejibu ya kwanza. Niliuliza Statement moja ya barabara mbili, imekuaje moja ndio inakubalika alafu nyingine bado? Kama Lodung'oro ni private land na wanasema kuna kesi, kwa nini walilipa kama



Lodung'oro? Ni kwanini hawakutoa ama waambie watu wakati ambapo walijibu hii Report? Kwanini hawakuandika Seketet Lemsigiyo? Kwanini walirudi kuandika Ledung'oro kama hiyo barabara ilikuwa kwa Private land?

Nataka kujibiwa kwasababu kama Lodung'oro ilikuwa private land ingetoka hapa si asilimia mia imefanywa na fulani na imelipwa pesa yote. Kwa hivyo bado sikubaliani nayo. Pia ni mimi niliambia Mheshimiwa Leerte kwasababu sitakuwa askilize watu hawa wa barabara vile wanasema kuhusu barabara zetu. Kwa hivyo sidhani kwamba kuna kitu tunaficha. Tunataka Habari kamili na watujibu Statement zote mbili kwa kuwa hakuna kitu tunakubaliana nayo.

Hii ni moja ya Lodung'oro pekee na je, ya Malaso junction Siambu?

**Mr. Speaker,** (Hon. Lenamarle Stephen): Hon. Lenamparasio I know you are also a member of the Committee.

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): Yes. Asante sana Mheshimiwa Spika nina kubaliana na uchungu Esther ako nayo na mimi niko kwenye Kamitii ya Barabara. Wakati Esther aliuliza hizo Statements, na ningependa Mheshimiwa Esther awe makini askilize. Wakati alipo uliza hizo Statements tatu, sisi tulikaa hapa kama Kamati ya Barabara na wakati hiyo hatukuwa tumefanya review ya standing orders. Wakati huo ndio Mheshimiwa Lekuchula alikuwa Chair kwasababu juzi tulipo fanya review ya standing orders tulitoa wale members wa County Assembly Public Service Board kwa Chairs.

Wakati huo tulikuwa na Mheshimiwa Lekuchula na wakati Esther aliuliza Statement hiyo ilikuwa barabara tatu na sisi tuliitana hapa kama kamati tukaketi chini na tukaandikia Department. Wakatupa mhandisi na tukaenda katika Wadi tatu. Tulienda Porro, Suguta na Loosuk kuangalia barabara. Karatasi ambazo Mheshimiwa Esther ako nazo ni the quarterly Reports that the Department usually forward to the Assembly. Statement hizo zilitoka katika hizo quarterly Reports.

Ningependa kusema ukweli, tulikuwa na Mheshimiwa Dube siku hiyo. Barabara ya Porro junction, Malaso tulienda tukiwa Kamati na Department haikuwa imefanywa na imelipwa. Ni vile Department haiwezi sema tulilipa na haijafanywa. Mimi nasema kama Kamitii ya Barabara tulienda na tukapata ya kuwa hiyo barabara haijalimwa lakini imelipwa. Siku hiyo tulienda



barabara tatu na hizo Mheshimiwa Esther aliuliza. Tulisema kama Kamati tuende tena Samburu North na East ili tuje tutele Ripoti Kamili.

We table the Report in this House so that we find a way forward on how to deal with these issues. Lakini juzi tuliambia the facilitation hakuna kuenda Samburu North na East ndio maana hatukuleta hizo Ripoti. Lakini ningependa kuambia Mheshimiwa Esther mbele Hon. House yakwamba tulienda na tukapata hiyo barabara haijalimwa hata kidogo. Afadhali hile kidogo inayo pita karibu na town walienda wakamwagilia murrum mahali kidogo. Siku hiyo tuliitana hapa na tukaomba tukisema twendeni na tuje tuseme haki bora tusiongeze kitu na tusifiche. Mheshimiwa Esther hiyo barabara haijalimwa. Asante.

**Specially Elected Member,** (Hon. Osman Dube): Mheshimiwa Spika tunakubaliana na vile Mweshimiwa Kaunda amesema. Chairman yule mwingine ameingia mkutano kadhaa na ni juu ya barabara na sio Porro pekee yake. Hata jana tulikuwa kwa Executive, na Mheshimiwa Esther tutakuhakikishia kwasababu tulikubaliana lazima tuzunguke kila Sub- County. Na kile ambacho umeulizania saa hii tutakuhakikisha, tutatembea na mahali wamefika tutayajibu vilivyo kisha tutaleta Ripoti. Naomba ile barabara ya junction ya Baragoi utupee muda tuende tuiangalie.

Pia kila wadi, ukiangalia hizo wadi 15 hakuna yenye haina shida ya barabara. Naomba sababu tumefika ile pande ya Executive department tutaenda tuangalie hizo barabara zote ambazo watu wanalalamika. Maoni yangu kama First Chair au Acting Chair saa hii naomba utupee muda, pia ile Mheshimiwa Esther na tutaleta Ripoti kamili. Asante.

**MCA Elbarta Ward,** (Hon. Leitoro Jeremiah): Thank you Hon Speaker. I arise on point of order number 50. The Hon. Members who have the current Standing orders, point of order number 50. On the content of question that you are supposed to ask. If I am right, I think this matter is still under investigation by the Committee of roads. What I have heard is if the matter is still not yet concluded by the select Committee, which is the Committee of Roads. Because whatever they heard from the Hon. Member is that they have not concluded the Reports simply because they have not visited Samburu North and somewhere else.

That is why the Committee has not tabled the Report pertaining to those roads. The rest of us as Members of this Hon. House expect that we receive a conclusive Report so that we can be able to ascertain in real that the roads were not done and were paid. Those were strong allocation. On

that matter of standing order number 50 content of creation Clause 3, k THAT a question shall not refer to proceedings to select Committee before that Committee has made it Report to the House.

Now that this matter seems to be taking so long, I do not know how we are going to handle it. Because the County Assembly of Samburu should be able to enable the Hon. Committee to conclusively deal with all matters pending on Roads. So that we are able to assert because it might even appear that some roads which have not been done in Elbarta and they have been paid. If it is possible, the Committee, that the selected to have a conclusive Report as soon as possible because this matter is under scrutiny by the select Committee.

I request that the Committee be enabled to conclusively make this Report and table so that we can be able to know on statements of facts. That indeed the road A, B and C has been paid and the work has not been done. Then from there we will be able to take measures. I beg that question to be put on halt until the select Committee conclusively has this matter once and for all.

**Mr. Speaker,** (Mr Lenamarle Stephen): Hon. Silapia do you have a different opinion?

**Specially Elected Member,** (Hon. Lenamatiyio Silapia): Hon. Speaker I just want to inform the Hon. Member for Elbarta Ward that this is a response from the department that we are reading. The Hon. Member is not accepting because it is not satisfactory. Second, the statement acquired by Hon. Lenolkulal Esther is on a financial year 2022/2023 and here we have the implementation status of 2022/2023 and this is where that statement originated from. And she has been following that statement since last year; I think we have now 9 months.

Recently, when we called the department, to appear before the Committee to explain the same and on the issue of this statement. They tell us that there is a dispute of land. Last regime this road was there and this is just an improvement. What happened that last time there was no land dispute? And Hon. Esther Lenolkulal is from Porro ward, Lodung'oro. And again, I am a member of the Roads Committee and I am not satisfied with this. They could have listed those people who are raising issues of land so that the Hon. Member can do a follow up on the same.

This statement has become a long overdue without satisfactory answer and Hon. Speaker it is now time you direct letter to the CEC to appear in this House and explain because the member

asks the statement as it is for this Hon. House and not the Committee. The Committees task is to address the Department to bring the response. We are not there just to satisfy ourselves and remain with the response and the Hon. Members are not satisfied with it.

This is a long overdue statement and we want the department to come before this House and explain and also list down those who are complaining on the same issue of land within this road. And when you look it is the same Department who are giving us this false information because this is an implementation Report for the financial year 2022/2023. And they are the ones who gave us as the Committee and here they have even mentioned the contactors name, the percentage work done, if its fully paid. Give us direction.

**Mr. Speaker,** (Mr. Lenamarle Stephen): Just give me a minute. I am been told the statements were two by the Clerk Assistant. One has been answered one remains unanswered. Na kile kitu nataka kuambia Department ni vitu viwili, moja, waketi chini kama Department tena, waite CEC ajibu hizimaswali mbele ya Department. Pili, Committee kama mumeenda wadi 3 tuwataka Ripoti ya barabara ya hizo wadi 3 Loosuk, Porro na Suguta wadi. Kwasababu kabla pesa haijaisha mulikuwa mumeenda hizo wadi 3. Mulete hizo Ripoti mbele ya hii nyumba tujadiliane. Lakini kwa hii Vice Chair muitee CEC mbele ya Kamati yenu ili mupate Ripoti zote. Asante.

**Specially Elected Member,** (Hon. Lenolkulal Esther): Asante Mheshimiwa Spika. Tuliomba hawa CECs waitwe mbele ya House ndio kila mtu aulize maswali zake. Tumechoka kujibiwa statement nusu nose. Mimi ningeomba siku hiyo wakiita CEC niwe hapo.

**Mr. Speaker,** (Mr Lenamarle Stephen): Mheshimiwa Esther atakuwa kwa hiyo Kamati kama Interested party. Lakini hatutaita ita CEC kwa House mbaka tupate kwanza Ripoti ya hiyo wadi 3 vile mulisema. Baada ya tukipata Ripoti 3 na pia CEC watakuwa wamekuja mbele ya Kamati wakati huo ndio tutajadiliana kama tutaita CEC waje hapa mbele.

**Specially Elected Member,** (Hon. Dube Osman): Asante sana Mheshimiwa Spika. Mheshimiwa Esther amekuja na pressure (*makes a joke*) kwa hii nyumba hii temperature yake apunguze. Tutajibu na tunataka hivyo, tukikosolewa tunapata nguvu ya kusaidiana na yeye. Kile kitu wamechelewesha ni tulitoa Chairman kitambo na kabla tuingie mkutano ingine tunazunguka na pia tunachelewa. Lakini tumeanza kazi na sio mbio. Mheshimiwa Esther tutahakikisha umeridhika nay e. Pia tunaomba wiki mbili na tutayajibu.

Mambo ya barabara nirudie kwanza ya private, ukipita hapa BP iko mahali imewekwa lami mbeleni na saa hii ni ploti ya mtu. Survey akikuja mambo mingi inaanza kuharibika. Mheshimiwa Esther tunaomba radhi kwasababu hii barabara ukiweka maneno ya survey inasongesha mashamba. Tutakimbisha na baada ya wiki mbili tutaleta Ripoti kamili. Asante sana.

**Specially Elected Member** , (Hon. Lenolkulal Esther): Asante Mheshimiwa Spika. Nikiwa nimengoja hizo mwezi tisa nafikiri nitapeana wiki mbili lakini hiyo barabara nyingine sijui shida yake ni nini. Nimepeana wiki mbili na hiyo ni ya mwisho.

### **Statement Number 5**

Statement request from the Chairperson of the Committee on Medical Services, Public Health and Sanitation regarding the employment management and remunerations of casual workers in the health department

**MCA Elbarta Ward**, (Hon. Leitoro Jeremiah): Thank you Hon. Speaker. This statement was responded to however it was not satisfactory. The Committee took an initiative on 7<sup>th</sup> April, 2025. We wrote a letter to invite the CECM of Medical services, Public Health and Sanitation. He was to appear on Monday 14<sup>th</sup> April, 2025 to shade some light on issues that have been raised and those that are not satisfactory. The letter was written on 7<sup>th</sup> April, 2025 and on the 9<sup>th</sup> April, 2025 we received a letter from the CECM of Medical services, Public Health and Sanitation, the Departments experienced some emergency situation in that area of Wamba West.

There was an outbreak of common cold. So, they requested that they be given time to respond to and today the Committee of Health had an interactive meeting with the CEC and CO Medical services. One of the issues we raised was on that specific statement which was not well addressed. And we requested them that this statement be responded to not later than 4<sup>th</sup> June, 2025 2:30pm. With your permission and of the Hon. House I think it will be prudent for us to give substantive response. Thank you.

**MCA Wamba West Ward**, (Hon. Lemartile Francis): Thank you Hon. Speaker. I appreciate the Chair for the response he has given us but as per the statement, being the one who has sought it. Because they submitted the list to big facilities, Sub-County and also other Health centers. But our main concern was that nothing was responded on our dispensaries. We have tasked the Chair

because to their Response they have given that in our dispensaries are funded and facilitated by an NGO I do not know Nadida.

So, we sought to know that they should bring also the breakdown of how many casual workers and names of facilities which depend on that programme. So, I think the time being 4<sup>th</sup> it will not be far; we give the Department time and a way to submit that. Thank you.

**MCA Nachola Ward**, (Hon. Lorunyei Lawrence): Mr. Speaker I feel pity for casual workers not to be attended to Mama mboga, Boda boda, the garbage collectors and cleaners for the Department not to respond to their needs. These casual workers do a lot of work especially those in hospitals. They depend on that 4000, 5000 or 6000 and staying that long without being cared for. How much suffering are you creating because they are many and we keep on postponing answering their calls?

This statement is very weighty and you know those social workers have got family, children who go to school and they have personal needs. And when we are denying them their remuneration we do not answer their call

**Mr. Speaker**, (Mr. Lenamarle Stephen): Order Hon. Lorunyei! Are you trying to anticipate the response? You know we do not know what the response will be and that is why we are saying on 4<sup>th</sup>. That is when we are going to get the response and then we will interrogate it. Let us not anticipate that they might not be paid. Continue.

**MCA Nachola Ward**, (Hon. Lorunyei Lawrence): I am concerned about the urgency. Keeping it for so long and they are suffering. Thank you.

**Specially Elected Member**, (Hon. Lenamatiyio Silapia): Thank you Hon. Speaker. I was supporting Hon. Lorunyei because the respond was here and he had something on mind about it and that is why he is saying we look on that issue. Let me not anticipate also I just want to tell this Hon. House for the Chair of the Health Committee at least we need to address such issues on the delay of the salary of casual workers. We need to know the total number of the casual workers within Samburu County and those who are working or helping in dispensaries of our Sub-County's also our wards. Thank you.

**Mr. Speaker,** (Mr. Lenamarle Stephen): Hon. Member you can wait up to 4<sup>th</sup> Wednesday at 9:30am so that we get a comprehensive Report about the payments then we can ask questions once we see. If Hon. Lorunyei has seen the response before it came, maybe he has a leakage. But now we are waiting for that response on 4<sup>th</sup> Wednesday.
