### **STATEMENTS**

MCA Waso Ward, (Hon. Lemantaan Kelvin): Thank you Mr. Speaker, pursuant to Standing Order 51/1 I hereby request for a Statement from the Committee chairperson on Education and Vocational training regarding lack of ECD teachers in Lmari ECD school, in Loosuk ward.

Pursuant to our Standing Orders 2 (1) and (2) 4(e) Sectoral Committee on Education and Vocational training is required t investigate and inquire into all matters related to pre-school Education, Village polytechnics, Youth polytechnics, Home crafts centers, children's and child care facilities. In view of this, the chairperson should inquire into a report on;

- 1) Why there is no teacher in Lmari since first term of 2025?
- 2) Is the Department aware that Lmari ECD is closed due to lack of a teacher?
- 3) Is the Department aware that Lmari ECD teacher retired and there is no replacement up to date? Thank you Mr. Speaker.

**Temporary Speaker,** (Hon. Lemoosa Jonathan): Very well Hon. Lemantaan, the Hon. Members and I want to refer this Question to the chairperson of the Committee on Education and Vocational Training, please guide us on this matter.

MCA Nachola Ward, (Hon. Lorunyei Lawrence): Thank you Mr. Speaker, it is our mandate just to inquire and bring the information to this Honorable House. Aware that we need to give a notice of 7 days today is Wednesday maybe next Wednesday, after two weeks I will bring the report Mr. Speaker. So that you can get the response and follow the procedure, thank you.

**Temporary Speaker,** (Hon. Lemoosa Jonathan): You also understand that you are a Member of the House and you need to be specific on the date and time, 7 days from now is 21<sup>st</sup> the 7 days will elapse on 28<sup>th</sup> May 2025, if actually this calendar serves me well.
