CECM LANDS, PHYSICAL PLANNING, HOUSING AND URBAN DEVELOPMENT RESPONSE

Temporary Speaker, (Hon. Lenamatiyo Silapia): Hon. Members, Pursuant to Standing Orders 47 (1) which provides that there shall be time, designated for Questions and Statements not exceeding two hours during a morning sitting and one hour during an afternoon sitting on Tuesday and Wednesday.

The CECM for Lands, Physical Planning, and Housing and Urban Development is appearing before the House in accordance with our Standing Orders.

The Sergeant-at- Arm, bring the CECM to the House.

(CECM enters the chamber)

Hon. Members, I take this opportunity to welcome the CECM for Lands, Physical Planning, Housing and Urban Development to this House in accordance with Standing Orders 48 (1) A Chief Executive Committee is requested to appear in the House to expound on Government policies, reply to questions and provide reports concerning matters under his/her control.

Also, our Standing Orders 51 (6) provide that the CECM shall appear in person on the day on which the respective question is listed for response on the order paper.

Hon. Members, Pursuant to House practice the CECM is required to take an oath or affirmation to provide truthful statements to this House.

I now oath invite the Clerk to administer the oath.

(CECM takes an oath)

Temporary Speaker, (Hon. Lenamatiyo Silapia): Hon. Members, this appearance is an occasion by statement request made under Standing Order 47 (2) by the Hon. Member for Loosuk Ward, Hon. Lenamparasio Phelix; concerning the land related project within the County, especially issues pertaining Loosuk Ward and Archers town.

I now invite the Hon. Member for Loosuk Ward, Hon. Lenamparasio Phelix to raise the statement.

MCA Loosuk Ward, (Hon. Lenamparasio Phelix): Thank you Madam Speaker. I rise to read my statement, I am the one who did the statement and the CECM is to respond to some matters relating to lands and urban planning, especially on implementation status of land related projects within our County and more so to issues pertaining Archers, Nasur and Loosuk town.

Madam Speaker, the CECM is supposed to respond to the following questions:

1. Provide a survey plan of Archers town.
2. Status of boundary of Nasur.
3. Provide a survey plan of Loosuk town before devolution.
4. Highlight all the already allocated plots by the owner's names, plot number, both residential and commercial (ownership document, allotment and payment receipt)
5. Who allocated plots in Mugur dam parcel?
6. Who receives money paid by plot owners in Loosuk?
7. Provide a list of Loosuk group ranch owners allocated parcels in Loosuk including their parcel number.

Madam Speaker, for the benefit of the Hon. Members if the CECM has some writeups for these questions, Members can be provided for so that as he responds, the Hon. Members can go through because it will assist them in creating some questions, thank you Madam Speaker.

Temporary Speaker, (Hon. Lenamatiyio Silapia): I welcome the CECM to respond to the questions raised, if the CECM has copies, kindly give them to the Hon. Members. Welcome Waziri.

CECM, Department of Lands, Physical Planning, Housing and Urban Development, (Mr. Loosenge David): Thank you Madam Speaker. I take this opportunity to thank you for this time.

I acknowledge the letter from The County Assembly of Samburu dated 29th May, 2025 vied reference SBU/CK/SCLPUH/VOL.1/7/2025 seeking invitation for me to appear before the House today.

As the Hon. Member for Loosuk has elaborated, I am supposed to respond to the following issues:

1. I am to provide a survey plan of Archers town.
2. Status of boundary of Nasur.
3. Provide a survey plan of Loosuk town before devolution.
4. Highlight all the already allocated plots by the owner's names, plot number, both residential and commercial (ownership document, allotment and payment receipt)
5. Who allocated plots in Mugur dam parcel.
6. Who receives money paid by plot owners in Loosuk.
7. Provide a list of Loosuk group ranch owners allocated parcels in Loosuk including their parcel number.

In regard to the foregoing, I beg to reply as follows:

- a) That Archers town had no survey plan but a draft local physical development plan/town plan.
- b) That Nasur village falls within Nasur Sub Location, Amaiya Location of Samburu County. In context, the village forms part of Longewan 'B' Group Ranch/Community Land that was adjudicated under Suguta Marmar 'B' registration section. It is critical to note that the neighbouring County (Baringo) equally has a Sub Location named Amaiya under Churo Location within the boundary between the two Counties being River Amaiya.
- c) Pre-devolution, Loosuk town had no survey plan but a draft local physical development plan/town plan that was used to allocate parcels by the Defunct County Council. The copy of that land is in here.
- d) That in response to question 5, the Loosuk draft plan and corroborated by the search for parcel Samburu/Suguta Marmar 'A'/26, the land that was reserved for Mugur dam is approximately 32 Ha and that should remain so. Loosuk town and Mugur dam share a boundary. From the information we have as an office, the parcel named Suguta Marmar 'A'/26 has not been tampered with by planning of Loosuk town.

If there is any boundary issue between Mugur dam and Loosuk town, then that is a mandated of Land Registrar to sort out the boundary issue.

- e) That in response to question 6, we have even said it in our previous response to the statement to this House we are not as a Department a revenue receiver. This issue can accurately be addressed by the CECM, Finance, Economic Planning and ICT in Revenue Section.

Those are the responses and annexes to the questions raised by the House.

Temporary Speaker, (Hon. Lenamatiyio Silapia): Thank you Waziri. Hon. Members, in accordance with Provision of Standing Order 51 (7), the Speaker may allow the Member asking the question to raise maximum of two supplementary questions that relate to that question.

Therefore, Hon. Lenamparasio, you may raise up to two supplementary questions, welcome.

MCA Loosuk Ward, (Hon. Lenamparasio Phelix): Thank you Madam Speaker. I think I will deal with matters pertaining Loosuk. I am not seeing the Member for Suguta Marmar Ward, Nasur is for Suguta Marmar, he is the one to agreeing or disagreeing with this response.

Hon. Lemantaan as well is not in the House to either agree or disagree with the first question, but I am seeing Hon. Rebecca, she may have something to say.

Madam Speaker, as par from question three up to the seventh question touches on Loosuk. On question three; the CECM is supposed to provide a survey plan of Loosuk town before devolution. I am seeing Annex 1. And the response as well .

Question four required the CECM to Highlight all the already allocated plots by the owner's names, plot number, both residential and commercial (ownership document, allotment and payment receipt). This question Madam Speaker has not been answered at all; I am seeing attached annex 2, the only annex here is annex 3.

Madam Speaker, I asked this question because many people living in Loosuk came to me complaining on the same. You find people having the same receipt numbers, people fighting over one plot and all these plots are being given by the County Government of Samburu.

I just want to tell you that question number 4 is not answered at all so that maybe so that maybe you can guide on your ruling as you continue. On number 6 on who allocated plots in Muger Dam I am seeing a very nice story here about Muger dam, it is always 32 acres, the CEC who comes from that area knows very well there people settled in that dam, constructed plots there and they have documents from the County Government of Samburu. It should not be a waste of time for us to be sitting here and asking the CEC or the Executive representatives to come and respond to questions here and they just take it lightly.

As the head of the Department you should have known who allocated these plots, if the Committee on Lands can just go there and see for themselves they will just go and see what I am talking about. This is a parcel that already has structures, people are developing and building plots, they have receipts from the County Government of Samburu, as a head of Department the CEC could have known who allocated these plots and even if it was done maybe before his tenure the information is supposed to be at the office because he holds an office and we are not asking him these questions as an individual but the office.

The sixth question on who receives money paid by plot owners in Loosuk, I like how the CEC has responded to that question that the CEC Finance has not designated department of Lands and revenue receiver. Madam Speaker with your guidance I want to do another Statement to the CEC Finance to come before this House and let this House know who collects money that are being paid by plot owners in Loosuk. I understand that before allocating a plot in any urban center and not only in Loosuk there must be a procedure somebody has to go to apply, you are supposed to be allocated, and you have to pay and then you are shown your plot.

I had asked this question very deliberately because I knew the CEC Lands do not collect revenue because the CEC knows very well the people who are collecting money from Loosuk plot owners and I do not think it is their mandate as individuals because any urban center within our County belongs to the County Government of Samburu. There was a day that we went to Archers we had commissioned a digital system of collecting revenue in Samburu County yet when you go to Loosuk people are collecting cash and giving receipts that may not be genuine.

In Loosuk there are a lot of insecurities and peoples animals driven away, someone remains with one cow and sells it to get a plot and give money to people whose receipts may not be genuine or

if they get that plot. It is that pain that has made me do a Statement. I will do a Statement through Chair of Finance; the CO Revenue has to come to this House to explain to me and to this House who collects these monies.

The last question is that I should be given a list of group ranch owners' allocated parcels in Loosuk and their parcel numbers. I have seen annex three and you know the history of Loosuk town is that Loosuk group ranch donated 900 acres for urban and it was an agreement between the group ranch members and the then County Council during plot allocations the first priority should be given to members of Loosuk group ranch that they should be given a one acre residential plot, I have the list here let me just be satisfied for some time because I have to go through this list, I am satisfied with question number 7.

I am not satisfied in what has been answered here apart from question number 7. For the survey plan before devolution I partly agree because I am seeing a map here and I am not a surveyor. So the 4th, 5th and the 6th question I need your guidance because they are not sufficiently answered, thank you Madam Speaker.

Temporary Speaker, (Hon. Lenamatiyo Silapia): Thank you Hon. Members, before I give the CEC to respond on the issue raised by Hon. Member for Loosuk Ward Hon. Members you may now raise supplementary questions permitted under Standing Order number 51/7/b provided they are relevant to the subject matter of the original Statement. Kindly remain within the bounds of the topic the land related issues pertaining the Archers and Loosuk town, welcome Hon. Members.

Specially Elected Member, (Hon. Lolosoli Rebecca): Thank you Madam Speaker. I think I do not have a question for the Hon. CEC because I met with the Lands Officers and they told me they are not yet through with Archers Post they are coming to complete the plan of Archers Post. So I do not think I have any question for him for now, thank you.

MCA Nachola Ward, (Hon. Lorunyei Lawrence): Thank you Madam Speaker. According to Standing Order number 51/5 and I read a County Executive Committee shall provide a Physical and electronic copies of a response to a question at least 24hrs before appearing before the Assembly. I have just received the copy whereby I cannot say anything. I see that this is a

deliberate to make this House not to engage in the matter seriously. Land is a very sensitive issue and as per the Department the CEC the same Standing Order 51/6/c whereby if I can read the County Executive Committee Member may with the permission of the Speaker make a Statement on any other matter pertaining to the Department, so we need to be informed about the land issue because it is across the County, The question was about the plots, there is allegation of double allocation and conflict, the CEC should tell us how many plots are there in Loosuk and the people who allocated the plots so that the issue of conflict comes straight, when a matter comes to this Hon. House we are collectively affected because everywhere there is this double allocation as the case of Loosuk, thank you.

MCA Wamba West Ward, (Hon. Lemartile Francis): Thank you Madam Speaker I just raise on concern raised by the CEC especially because Hon. Members a lot of questions have been asked about Nasur and the Hon. Member who sought the information is not around but the concern of this House is the CEC to make clear whether our borders are secured because the response given by him is just that the two Counties are separated by river so we want to be assured about our border and how secure are they. Because when we are discussing the Statement before there were questions of the neighboring County developing some public utilities within our borders without the concept of our County?

I wish the CEC to make it clear and also my last concern as per Hon. Lorunyei has put it I do not think whether the Department were serious to the question asked by this House because the Hon. Member asked to make it clear provide a register showing names and parcels allocated to a person but annexure two is not a legally binding document with a lot of errors because the first column is plot number, name, ID number, size it has several blank information some without plot number some without ID number, some without anything, you can go to plot number 611 which is still blank but the Department is providing us with information not binding to this House because if it was a register being used to allocate it could have a clear order whether alphabetically or plot number but this one has no legitimacy or legal framework to accept it, it does not show anything.

So the information given pertaining the list has no legitimacy according to how I see it. The CEC should put it clear what is this annexure two because the Member sorted to give the names but

has a lot of errors, so they should respect this House and bring something very tangible and binding by law signed by them so that we can take it as a binding document, thank you Madam Speaker.

Temporary Speaker, (Hon. Lenamatiyo Silapia): Thank you Hon. Members. Let me now take this opportunity to give the CEC so that you can answer those questions.

CECM, Department of Lands, Physical Planning and Urban Development, (Hon. Loosenge David): Thank you Madam Speaker. I think I can start first with the Mugur dam that was raised by Mheshimiwa Kaunda Lenamparasio and I and he know that the planning of Loosuk was done way before he was elected and before I was appointed CEC; as I said earlier Loosuk town and Mugur dam share a boundary and when they did the planning before we came in they planned the entire parcel for Loosuk town that borders Mugur dam. Even before 2022 elections most Members know that we had a very huge insecurity issue so everyone that was living away from town towards the other side the insecure border moved to town and most secure part of that town is along Mugur dam and by that time no one was living along those plots, it was away from the old town, so when these people migrated from their farms everyone was going to that side of the town they look for a plot and live there, so most of the people living within Loosuk new plots are IDPs who have been affected by insecurities, if it were us who planned...

(Point of Order by Hon. Lorunyei)

Temporary Speaker, (Hon. Lenamatiyo Silapia): Hon. Lorunyei what is the Point of Order.

MCA Nachola Ward, (Hon. Lorunyei Lawrence): Madam Speaker the CEC seems to be misleading this Hon. House; the questions were very clear that is there any demarcation in Loosik town, yes or no. How many plots were there, yes or no because to be official Madam Speaker the official record must be in the office. We are asking the office and the records are there, does it mean that the CEC does not know about the office, the office was not handed over, information we are getting at the last minute so that we do not go through. If plot number, the owner, the ID and the phone number is not here and then this official document is brought to this House how can we honor this Madam Speaker. It means that the CEC does not know his office;

my concern is the CEC is misleading this Hon. House because we want to be serious with issues here.

Temporary Speaker, (Hon. Lenamatiyo Silapia): Hon. Member for Loosuk.

MCA Loosuk Ward, (Hon. Lenamparasio Phelix): Thank you Madam Speaker. I just want you to direct us here if you yourself as the Chair of this House today that you will just get sited here to waste our time and move out just like that, I earlier said that we are not asking these questions to an individual person we are asking an office. We are not asking the honourable CECM as a person we are asking the office, and honourable Madam Speaker some of us cannot be sitting here wasting our time because it is funny that what Honourable Lorunyei doesn't know and I know because I'm from Loosuk, the annexure 2 and 3 are just the same the number 1 person is same in the other annexure.

The annexure 3 is for the people of Loosuk group ranch. If the fourth question is answered from this Statement, how many plots are in Loosuk and how many have been allocated and how many haven't been allocated, at least I will be satisfied. So kindly direct should we should we sit here waste our time or the CECM should respond to issues because he came here

He is the head of that office and he had all this time to go through all these questions and he should have come here to respond to all these questions the way we wanted like every other Member.

Temporary Speaker, (Hon. Lenamatiyo Silapia): The CECM please summarize then I'll give the directions.

CECM Land, Housing, Physical Planning and Urban Development, (Mr. Loosenge David): Madam Speaker since I sorted this Statement, I am seeing that there is nothing we're being told here. I don't know how you'll direct but I'm not seeing any sufficient information given to this House. It is so bad that all these Members are seated here listening to nothing and then we move out. If the CECM is going to respond, we want satisfying information, Thank you.

Temporary Speaker, (Hon. Lenamatiyo Silapia): Waziri you can continue to reply. I will give my direction.

CECM, Department of Lands, Housing, Physical Planning and Urban Development, (Mr. Loosenge David): Thank you Madam Speaker, I think I am just going question by question so maybe Hon. Lorunyei is tired of me because I wanted to explain why we don't have a list of the ones that are not non-member. The list that we are provided is for question number 7 that gives out names, plot numbers, ID numbers and phone numbers for the group ranch members, that is the list we are provided.

This other list we are doing compilation of it because 1; Initially these plots were never located even by the previous regime but once the insecurity issue set in, we have had almost all plot occupied by the IDPs so we're doing some regionalisation and we'll provide the correct list of the current occupants of the plots within Loosuk town but we have provided for group ranch members.

Temporary Speaker, (Hon. Lenamatiyo Silapia): Waziri I want you to be clear. So, you are saying that you have answered the list that is there attached to this document is for question number seven so number four questions is not answered or what you want to tell us.

CECM, Department of Land, Housing, Physical Planning and Urban Development, (Mr. Loosenge David): We are compiling that list because as I said most of the plots are occupied by people who have not been allocated by the county government. People who have settled because of insecurity and mheshimiwa Kaunda know that. We are doing legalisation and we will provide the correct list on...

MCA Nachola ward, (Hon. Lorunyei Lawrence): Point of Order madam Speaker.

Temporary Speaker, (Hon. Lenamatiyo Silapia): What is the point of order Hon. Member for Nachola?

MCA Nachola ward, (Hon. Lorunyei Lawrence): Still I don't understand madam speaker because the reports are there and rents are being paid. I don't know this contradiction that the departments have not allocated any plots and why is the payment going on. That is why I'm confused. The CECM must be very clear. If the office is not aware of what is going on their people or another government taking money there out of what the department knows because plots are there and rents are being paid and the people are complaining so I'll like the CECM to be very clear.

CECM, Department of Land, Housing, Physical Planning and Urban Development, (Mr. Loosenge David): Thank you Mheshimiwa...

Temporary Speaker, (Hon. Lenamatiyo Silapia): Okay thank you member for Nachola ward I'll give direction. Let the CEC finalize and then I'll give.

CECM, Department of Land, Housing, Physical Planning and Urban Development, (Mr. Loosenge David): Thank you madam Speaker on the issue of plots I think we have three categories of plots in Loosuk, one for the group ranch members the allocation of one acre per member and then we have plots allocation to members by Samburu County Council and there is this bit of the new plots when the entire town was planned and that is what I was telling this Hon. House.

We are compiling the list of those new plots because most of those members have not been allocated properly by the county government. They have settled there because of insecurity. I think mheshimiwa Lorunyei I'm clear.

Temporary Speaker, (Hon. Lenamatiyo Silapia): Honourable Waziri you have to address me not the honourable member. Answer those questions remaining so that I can rule.

CECM, Department of Land, Housing, Physical Planning and Urban Development, (Mr. Loosenge David): So, there's also the issue of Nasur that was raised by honourable Lemartile. I want to agree with you that we have given the correct information about Nasur and as we reported earlier in our invite by the committee of lands in this house. Nasur is occupied and built by the Member of Parliament for Baringo. As we said that time, on this county assembly level, we may not be able to address the Nasur issue. That is a parliamentary question because we need to ask the Member of Parliament for Tiati why he's doing projects in Samburu West, about where Nasur is that is correct information we have given you, Thank you.

MCA Maralal Ward, (Hon. Loloju Joseph): Point of Order Madam Speaker.

Temporary Speaker, (Hon. Lenamatiyo Silapia): What is the point of order honourable Loloju

MCA Maralal Ward, (Hon Loloju Joseph): Yes, Hon. Speaker, thank you so much. I want to somehow be clear on the issue of Nasur. I know very well know that the CECM comes from that particular area he knows it like the back of his hand just like I do.

The Hon. Member Leleruk who asked that question and that is his ward. He went to that particular area and saw with his own eyes what is happening there. The CECM cannot stand there and lie to us that Nasur does not belong to Samburu County. Samburu County indeed extends to the shores of Lake Baringo inside is where our beacon is. It is only that it has been taken over by the Pokot people. It is not his problem it is for us to defend our land.

Therefore, the CECM cannot say that the MP for Tiati or the question belongs to parliament when the land belongs rightly to us. He knows very well that it almost extends to Tinka B and I am sure himself is allocated there. Bwana CEC please come out clearly and tell the honourable house where Samburu county beacon is since that one is in Lake Baringo. I know it for sure and I can give you for free. Thank you, Madam Speaker.

Temporary Speaker (Hon. Lenamatiyo Silapia): Hon. Loloju you need to address me not the CECM so you are out of order.

MCA Maralal Ward, (Hon. Joseph Loloju): Thank you I apologise.

Temporary Speaker (Hon. Lenamatiyo Silapia): Hon. Sarah Lekirenyei

Specially Elected Member, (Hon. Lekirenyei Sarah): Asanti Madam Speaker. Ukijaribu kuangalia mambo ya mchanga imekua magumu Kaunti yetu ya Samburu. Side ya Baragoi bado tuko na mambo ile tu haijawahibadilika, Hon. Member stick to the matter that is before us. If you have any issue to do with Baragoi then you have to write a statement and ask for it. Now stick on the issue of Loosuk, Nasur and Archers town. The matter that is before us.

Specially Elected Member, (Hon. Lekirenyei Sarah): Sawa Madam Speaker asanti. Nilikua nakuja hapo mahali ya Loosuk. Unajua kila mahali county yetu inatuhusu na tuko hapa kwa sababu ya watu wetu. Ukiangalia story ya Loosuk Baragoi na Noomotio tumeongelelea tangu na Nomotio farm bado haijakua hata beacon sijui tunaelekea wapi. Mimi ni member wa committee ya lands. Hatuna communications kutoka kwa hiyo ofisi hata kazi yetu tumeshindwa kufanya kwa sababu tukienda hata hiyo ofisi kuna madharau mingi ndio maana unaona haya yote yanatokea. Leo tunataka kuona directions zako zinaenda wapi tupate kusaidika kwa hii mambo ya mchanga ya Loosuk kwanza. Asanti.

Temporary Speaker, (Hon. Lenamatiyo Silapia): Hon. Asha.

Specially Elected Member, (Hon. Mohammed Asha): Thank you Madam Speaker. I want to ask the CECM about the Nasur because I remember the other time I'm the one that wrote the statement. This Nasur thing honourable CECM if Nasur is in Samburu county and the people of Baringo have built it who is supposed to address this issue if already the member of parliament has built there it means that Nasur is not in Samburu county anymore. They have already built the schools and hospitals. My question is who is supposed to address this issue. Thank you.

Temporary Speaker, (Hon. Lenamatiyio Silapia): Honourable member for Porro ward.

MCA Porro Ward, (Hon. Leerte Patrick): Asanti Madam Spika. Maneno ya Nasur hii ni mara ya pili Statement imeulizwa...

Temporary Speaker, (Hon. Lenamatiyio Silapia): Waziri note the questions.

MCA Porro Ward, (Hon. Leerte Patrick): Madam Speaker ingawa waziri amezungumzia mambo ya Nasur. Sisi tunajua nasur iko insecurity kwa sasa. Tulikua tumerequest committee iweze Nasur kuangalia vile Hon. Asha anasema kwa sababu mpaka saa hii mimi sijaenda Nasur lakini kama hatujaenda kwa ground kuangalia hata itakua kazi bure tutauliza waziri kwa sababu tunataka kufika kwa ground kama Committee na Members Hon. Leleruk na Hon. Caunda kwa sababu Nasur imejengwa structures kadhaa na mpaka wa leo hatujui nani ako pande gani.

Sisi katika boundary tunajua iko pande yetu lakini naomba direction yako kwamba Committee na Department watembelee Nasur na kuleta report kamili kwa hii house kwa sababu CECM yale atasema sisi kama Committee hatuna uhakika. Kwa hivyo, tunataka hiyo Nasur tufike kwa njia yoyote hata kama tutapewa security ya askari ya kifarua iende huko sisi surveyors Committee na Members wa hizo wards tuweze kufika huko tupate ukweli ndio kama itaulizwa beyond Samburu County tutakua na facts ya kuuliza. Asanti.

Temporary Speaker, (Hon. Lenamatiyio Silapia): Honourable Lenolkulal the last member I'll give to ask a question so that we can let the CEC.

Specially elected member, (Hon. Lenolkulal Esther): Thank you madam Speaker. Nimesimama tu kwa sababu ya maneno ya Nasur na tukiongea kuhusu maneno ya Nasur pia wakati hiyo ingine niliongeza maneno ya Malaso kwa sababu tuko na shida ya Nasur na hatujafika kama kamati. Tuliona kama land ya Samburu ilienda na ndio maana tulikua tunaambia CEC tunataka

watueleze vizuri hata kama ni national government inahusika ipatikane habari kamili kwa sababu tunapoteza mchanga.

Ukiskia Nasur imejengwa sana na Hon. Kamket shule na hospitali na tukiongea maneno ya Nasur na wengine wetu hatujaona kwa macho, kama Samburu county tunapoteza mchanga yetu nyingi. Ata ukiangalia maneno ya Malaso kuna madini wanachimba na kupeleka Baringo. Kwa hivyo, hivi karibuni kama serikali ya county government haitaweka maanani maneno ya mchanga tutapoteza hadi group ranch zetu kwa sababu ukikuta county government ya Baringo ndio inajenga barabara ya kufika Nasur na Malaso huko ndani kwa hivyo nauliza CECM kama county government ya Samburu mmeeka mikakati gani ili tuweze kuokoa mchanga yetu ambayo itakuja kwenda kwa watu wa Tiati.

Hata saa hii tunaishi kwa shida kwa mashamba yetu personal kwa hivyo kama county government mmeeka mikakati gani kuokoa Nasur na Amaya kwa sababu Amaya ni Samburu county nani ndio chief wa Amaya. Unakuta watu wanatawala huko, machief na walimu ni wao na pia mashule ni zao. Tukikaa for two years maneno ya Nasur kama hakuna mwelekeo tumeeka kama Samburu sioni tukiokoa mchanga yetu. Ningeomba CECM atueleze mikakati wameeka kwa sababu department ya lands iko na budget ya kufanya hivyo...

MCA Nachola Ward, (Hon. Lorunyei Lawrence): Point of order madam speaker.

Temporary Speaker, (Hon. Lenamatiyio Silapia): Honourable Lorunyei what is the point of order. I am giving you thirty seconds please.

MCA Nachola Ward, (Hon. Lorunyei Lawrence): Yes, madam speaker there are straight forward questions here question number 4 and 5 about plots. In number 4 about the ownership documents allotment letter and the receiving of the plots of Loosuk

Temporary Speaker, (Hon. Lenamatiyio Silapia): Hon. Member for Nachola ward I'll give directions please

MCA Nachola Ward , (Hon. Lorunyei Lawrence): Give me time madam speaker like the allotment plots in Mugur dam the CECM to answer that if there are plots so that I leave this Honorable House knowing that there are no plots and if there are elaborate to us. Those are the questions I have for the CECM.

Temporary Speaker, (Hon. Lenamatiyo Silapia): Hon. Members let me give the CECM the chance to answer those questions please. I'll give you five minutes. Yale yaliyoulizwa kwa Kiswahili unajibu na Kiswahili na ya English unajibu na kiingereza.

CECM, Department of Land, Housing, Physical Planning and Urban Development, (Mr. Loosenge David): Thank you madam Speaker. You have talked about Nasur for quite some time and as I said I want to confirm that Nasur and the extension, Malaso is in Samburu County we especially members from those wards all know the magnitude of the complex insecurity issues we are currently handling in those areas.

When I was a young boy I used to herd in Nasur and even schooled in Amaya primary lower classes but for the last about twenty to thirty years our people have been displaced from Amaya location which is part of Loongewan group ranch B and so is Nasur. What we have done as a county, the Bs for Loongewan, Loosuk, Lolmolog, Malaso and Tinga they are all registered and we have titles. We even have active community lands management committees in our various locations.

What the county government is doing and is being done in the previous regime is to register the unregistered community lands between the Bs and the boundary of Samburu and Turkana county. There's a bit of unregistered land which is producing the Cs Loosuk C, Tinga C, Malaso C and Porro way and Nami. That is where we are. We have done an inventory and we're currently doing for Loosuk and Tinga C. We will do for Malaso and Porro way Administration so that our people have titles. But the truth is we are not living in peace all our peace is occupied by the Pokot's and we cannot lie to ourselves that we live there. The construction within our group ranches as I said earlier is beyond this Hon. House. We need to address it from the security perspective and also from the National Assembly's because I do not think it is legal for any member of parliament to come and like say Samburu East Member of Parliament doing classes in Samburu West.

I do not think there is any legality or the loss of this country allows the members parliament to do roads, dispensaries, schools in other constituencies. It is time for all of us the Assembly the leaders in this County to come together and address that issue. It is a very complex issue the Porro ward MCA or the Suguta Marmar ward MCA cannot address it. It is a big issue and a

serious one affecting those boards and we need to see how to get over it. But the good thing about the list we all have registered them and they have the titles.

The bit that is remaining is the CEC but God willing maybe before the election 2027 we will be able to have registered all the CEC. From there we will have to have a lot of conversation about how we will resettle our people back to the group ranches one day. Maybe not this year maybe not next year but we have to have this conversation. We understand mining works going on in Malaso. What is being mined? No one knows what is being mined in Malaso by the people of Baringo with zero revenue coming to the County Government and zero benefit coming to the members of that group ranch.

Which is registered and they have a title in Porro but whatever benefits they are supposed to get from that resource is enjoyed by people who are not members from this County. That is a bit complex and it is time to bring our heads together and think about Nassur, Malaso and all other occupied group ranches within our Samburu West constituency. I think I have conclusively addressed the Nassur issue.

And again, on ownership I said earlier madam Speaker. We have three categories on land parcels in Loosuk:

The one for group ranches members. We have provided a list for the beneficiaries for group ranch members. We also have a list for the people who have been allocated by the Samburu County council that is the old list. It is there in the office we will provide them. And then there is a new list for the new plots after the planning of the entire town. We are doing a regularization exercise for those who are in those parcels.

And I am very sure what Hon. Kaunda was talking about, the receipts. We do not control the revenue department. They might have given those receipts to so many individuals but as the department what we are doing is going to the ground and regularizing who is in parcel. Example Number 20 is it Loosenge, who is it? And we regularize the allocation to that person and those who might be having receipts and they do not know where the plots are. I am sorry to report but I might not be of good help to them. Because the entire town is occupied and most of occupants are people who have been displaced by the same complex problem we are talking about, insecurity.

MCA Nachola Ward, (Hon. Lorunyei Lawrence): Through Madam Speaker are there receipts? Are there rent for those plots?

Temporary Speaker, (Hon. Lenamatiyio Silapia): Waziri Continue. And also address that.

CECM, Department of Lands, Physical Planning and Urban Development, (Hon. Loosenge England): Madam Speaker as earlier said receipts from the revenue departments are being given to individuals who are not living in Loosuk. There are receipts and the best person to address is the Revenue Bit and the issuant of those receipts because we do not issue receipts. The best person to address anything concerning money and Revenue is the CEC Finance.

Temporary Speaker, (Hon. Lenamatiyio Silapia): Waziri on the issue of revenue I think we will have a time and discuss with the CEC, Concern on the treasury. Please continue with other questions we are remaining with three minutes...

CECM, Department of Lands, Physical Planning and Urban Development, (Hon. Loosenge David): I am even finished. As I said earlier about Mugur dam and Loosuk, they share a boundary. When planning was done, Mheshimiwa Kaunda and I were not there. Ideally the buffer zone would have been left to safeguard that very important resource, the Mugur dam, but unfortunately the entire town was planned and beaconed. By the time we settled, insecurity also started and the owners of those farms moved away from them and settled in most of those plots within Loosuk town. By extension even those bordering the Mugur dam. Thank you Madam Speaker.

Temporary Speaker, (Hon. Lenamatiyio Silapia): Thank you waziri you can now sit down. Thank you honourable members allow me take this opportunity to let Loosuk ward's Hon. Member say something on the same so that I can give directions.

MCA Loosuk Ward, (Hon. Lenamparasio Phelix): Thank you so much Madam Speaker...

Temporary Speaker, (Hon. Lenamatiyio Silapia): Please take 2 minutes.

MCA Loosuk Ward, (Hon. Lenamparasio Phelix): Yeah I will be very quick. Madam Speaker you know I was the original sorter of this statement. These are serious issues from the community but I will be very brief. I just want to let you know that from this statement like I said earlier, I have only agreed partially on number 7 because I have the list of group ranch members.

The biggest problem is the authenticity of the register. There are some names do not have ID numbers and some plots have no numbers, so I am not sure how authentic this register is. If I was in that seat today, the only thing that will solve the issue of Loosuk urban town and all this mess can only be an ad hoc committee but luckily I am not in that seat. The good thing is that the CEC and I are from that place. We both know everything and I agree with him when he says that during the insecurity from the Pokots, many people migrated to towns.

There are 2 things I want to understand from the CEC as you give your directions. Does the department of lands have a directorate by name survey because I know any planning is done by Surveys? These are people that went to university and mastered survey. The CEC coming here to tell us that the Mugur boundary and Loosuk town share boarder, you know even though I am not a surveyor, these two entities share boarder.

There is a surveyor here who is a technical person who is supposed to know where the boundary of point A ends and where that of point B starts. The CEC saying that the Loosuk people came to settle in Mugur dam, I want to challenge him to tell this house 2 things. If Loosuk people went and settled in Mugur dam, who beaconed for them where they are settling now in Mugur dam because you see beacons for yourself when you go there. To me what I understand beaconing is only done by surveyors.

The second thing, I am just going to mention it because I do not even want him to address. Who gave the people living in Mugur dam the receipts for payment? Because the receipts got the County Government of Samburu name. Have they given themselves? Allocating people plots is a process so the CEC should tell us what he is not telling us here. If there is another time the CEC will come to this house to tell us how many plots are in Loosuk town, how many are located, how many are not, who hold the membership register.

That is a government's office not somebody's business. I have a plot in Loosuk and what I expect if I go to the lands office is to be easily shown where my plot is, its number, do I have any revenue to be remitted to the County Government. The last thing before you give your ruling is all these people living in Loosuk, You know nobody has ever been given or has been shown where their plots are. And we go to the chief's office every Tuesday because every Tuesday they have some sort of meetings in chief's office some civil cases, I think 90% of the cases are for

plots. So you see these people are giving chief a lot of rough time because chief has never allocated any plot but people are just fighting over these plots every day.

There have been always civil cases, people are even cutting others with pangas because of that plots. It is the mandate of the county government of Samburu especially the department of land to make sure that people of Loosuk should not continue fighting because of these plots; they are supposed to come and let everybody know where their plots are and be given their documents so that when you want to do some development then you do.

But if we are always fighting with pokot and also fighting amongst ourselves, just some fights that has no meaning. So, madam speaker I just want you to kindly give this statement a fair ruling because to me am not satisfied at all.

Temporary speaker, (Hon. Lenamatiyo Silapia): thank you Hon. Member for Loosuk ward. Thank you Hon. Members, thank you waziri. According to our standing order number 1; in all cases where matters are not expressively provided for bind this standing order or by other orders of the county assembly in any procedural question shall be provided by the speaker, subject to the provisional program 2 of this standing order.

So, Hon. Members I want to rule this that the Hon. Executive member for land would address the question 2 to 3; provides a survey plan for Loosuk town before devolution. 3 highlight all the already allocated plots by owner's name, plot number, plot residential and commercial ownership with ownership documents allotment and receipts. Number 3 who allocated Loosuk in Mugur dam passes.

Number 4 who received money paid by plot owners in Loosuk. Hon. Waziri you have to bring a comprehensive report to this house on next Wednesday 9:30am that's on 11/6/2025 and Hon. Waziri this matter have been here for long and I think that day we will give a ruling and you might not like the way we are going to rule so, on that day that's on Wednesday 11/6/2025 you will be here appearing before the whole house and have to present a comprehensive report on the same issues concerning Loosuk ward.

The issue of Archers post, I think the Hon. Member is not here. So, on that day you will appear he might be having some issues the same and on the issue of Nasur the same day you will give

direction on the same. So, you will have to answer them that day; the issue of Nasur and of Archers post. Thank you Hon. Members, thank you Hon. Waziri you can all go with your own pleasures so that we can have other issues to do. Sergeants at arms lead the wazee out.
