Temporary Speaker, (Hon. Lenamparasio Phelix): Hon. Members, it is notified that the following statements and responses to Members general statements on topical issues is due on today Wednesday 4th June, 2025 at 9:30am pursuant to our standing order number 51(b) and standing order number 53(1), (2) and (3) respectively. The statement request was from the Chairperson of the committee on medical services public health and sanitations regarding the employment, management and remunerations of casual workers in the health department. Chairperson Committee on Medical services, Public Health and Sanitation, (Hon. Leitoro Jeremiah): Thank you Hon. Speaker. MCA Nachola Ward, (Hon. Lorunyei Lawrence): Mr. Speaker I do not know what the Hon. Member means by Special duties. Is it not special when Assembly asked for an issue? As the Hon.
