## **THE SAMBURU COUNTY FINANCE BILL, 2025 (SAMBURU COUNTY BILL No. 3) FIRST READING**

*The Samburu County Finance Bill, 2025, a Bill for an Act of the County Assembly of Samburu to provide for the imposition of variation of various permit fees, cess, license fees, rents, rates or charges and for other revenue raising measures of the County government and for connected purposes.*

**MCA Loosuk Ward**, (Hon. Lenamparasio Phelix): Thank you Hon. Speaker. I am surprised to see a Motion of The Samburu County Finance Bill, 2025, (Samburu County Bill No.3) first reading.

Hon. Speaker, if everybody goes to Public Finance Management Act section 41 if you feel like, and, I hope that today; the king of Executive defense forces might not query where the report is.

Section 41 of the Public Finance Management Act... (*Interjection by the Deputy Speaker*)

**The Deputy Speaker**, (Hon. Lelenkeju Jackson): Hon. Lenamparasio, respect your colleagues, concentrate on what you are speaking.

**MCA Loosuk Ward**, (Hon. Lenamparasio Phelix): But have said that am not respecting them?

**The Deputy Speaker**, (Hon. Lelenkeju Jackson): What is government... (*inaudible*)

**MCA Loosuk Ward**, (Hon. Lenamparasio Phelix): I know you belong there that is why you are bitter. Hon. Speaker, let me continue, you cannot force me to say what I do not want to say... (*Interjection by the Majority Leader on a point of order*)

**The Majority Leader**, (Hon. Loloju Joseph): Mr. Speaker Sir, I beg to know who is the king as referred by Hon. Lenamparasio.

**MCA Loosuk Ward**, (Hon. Lenamparasio Phelix): Thank you Mr. Speaker. Do not pretend, you know who the king is... (*Interjection by The Deputy Speaker*)

**The Deputy Speaker**, (Hon. Lelenkeju Jackson): Hon. Lenamparasio... (*inaudible*)

**MCA Loosuk Ward**, (Hon. Lenamparasio Phelix): If I may say, Section 41... (*Interjection by The Majority Leader and The Deputy Speaker*)

**The Deputy Speaker**, (Hon. Lelenkeju Jackson): Order Hon. Lenamparasio. There is no provision for debating, you are out of order...

**MCA Loosuk Ward**, (Hon. Lenamparasio Phelix): I want to ask something...

**The Deputy Speaker**, (Hon. Lelenkeju Jackson): Sit down please

**MCA Loosuk Ward**, (Hon. Lenamparasio Phelix): No, I cannot sit, Hon. Speaker...

**The Deputy Speaker**, (Hon. Lelenkeju Jackson): Hon. Lenamparasio...

(*MCA Loosuk Ward reads the Public Finance Management Act section 41*)

**The Deputy Speaker**, (Hon. Lelenkeju Jackson): Hon. Lenamparasio this is a House of orders, both of us cannot stand at the same time...

**MCA Loosuk Ward**, (Hon. Lenamparasio Phelix): No, I can stand, I have the right to talk...

**The Deputy Speaker,**(Hon. Lelenkeju Jackson): Hon. Lenamparasio, please sit...

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): Let me say what I wanted to say, you cannot just bulldoze me not to say what I wanted to say...

**The Deputy Speaker,** (Hon. Lelenkeju Jackson): Hon. Lenamparasio, there is no provision to debate, kindly sit down...

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): Even if there is no provision for debate; I just have an enquiry, I wanted to be enlighten...

**The Deputy Speaker,** (Hon. Lelenkeju Jackson): Hon. Lenamparasio, we cannot transact business like this, sit down...

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): No, we have to...

**The Deputy Speaker,** (Hon. Lelenkeju Jackson): Sit down, it is an order from the Speaker...

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): No, no, no...

**The Deputy Speaker,** (Hon. Lelenkeju Jackson): Sit down...

**MCA Loosuk Ward,** (Hon. Lenamparasio Phelix): Continue defending your government.
