The Speaker, (Mr. Lenamarle Stephen) in Chair

PRAYER

Specially Elected MCA, (Hon. Lenamatiyio Silapia): Hon. Speaker, the House does not have quorum. So, I do not see the need to continue with the business, the quorum is supposed to be nine Hon. Members but we are only four and it is a serious matter to this House Hon. Speaker.

The County Budget and Appropriation Committee shall thereafter consolidate the recommendations of the Select Committee taking, into account the reviews of the County Executive Committee Member responsible for Finance and table its report before this Assembly for consideration and adoption as provided under Standing Order 228 (5) and (6).

The Clerk is directed to circulate the estimates to all select Committees forthwith, I thank you.
