

2 PREFACE

2.1 BACKGROUD

Article 185 of the Constitution of Kenya, 2010 provides that the legislative authority of a County is vested in its County Assembly. A County Assembly is empowered to make laws necessary for effective discharge of functions under the Fourth Schedule.

Standing Order 173 of the newly revised Standing Orders of the County Assembly of Samburu provides for the reconstitution of the Committee on Selection to enable nomination of Members to various Assembly Committees.

Pursuant to the direction by the Hon. Speaker through his Communication from the Chair dated 9th September, 2025, the Committee on Selection was reconstituted and approved by the House on 16th September, 2025.

2.2 INTRODUCTION

Pursuant to Standing Orders 171, 172, 174, 175, and 212, and following the Speaker's Communication dated 9th September 2025, the Committee on Selection convened a retreat at Eagle Palace Hotel, Nakuru County, from 23rd to 25th September 2025.

During the retreat, the Committee deliberated comprehensively and nominated Members to serve in the various Select and Sectoral Committees of the County Assembly.

2.6 COMMITTEE SITTINGS

2.7 SUMMARY

In executing its mandate, the Committee adopted the following criteria:

- ✓ Political party strength and proportionality
- ✓ Gender balance and inclusion of youth and marginalized groups
- ✓ Member preferences and professional background
- √ Regional/ward balancing across the County

The Committees were grouped into Sectorial and Select Committees, with each Member assigned fairly to ensure active and productive participation. The proposed County Assembly Committees are as follows;

The above committees were clustered into two groups: Sectorial Committees and Standing/Select Committees. This categorization was aimed at streamlining committee operations, improving attendance coordination, and enhancing overall efficiency and performance in the execution of committee mandates.

Honorable Members,

The Committee on Selection undertook extensive deliberations and, upon conclusion, duly nominated Members to serve in the various Committees of the County Assembly, as outlined in the subsequent sections of this Report

2.8 COMMITTEE'S RECOMMENDATIONS

The Committee recommends that the County Assembly adopts the **Third** Report of the Committee on Selection on the Reconstitution and Placement of Members into Sectoral and Select Committees, with or without amendments.

Further, the Committee notes that the number of Committees in the Assembly significantly exceeds the available number of Members, and that the Minority Party is represented by a small number of Members. Consequently, to ensure functionality and quorum in all Committees, several Members have been nominated to serve in **more than two Sectoral Committees**.

This arrangement is in line with Standing Order 174(3), which provides that:

"Except as the County Assembly may otherwise resolve, on the recommendation of the Committee on Selection for reasons to be stated, no Member shall be appointed to serve in more than two Sectoral Committees and more than one special select committee."

In this regard, the Committee recommends that the House **resolves to allow** this deviation from the standard limit, on account of the necessity created by the Assembly's composition and operational needs.

The Committee further urges the House to support this recommendation to ensure that all Committees remain fully constituted and are able to discharge their legislative, oversight, and representative responsibilities effectively.
