MCA Loosuk ward, (hon. Adamson Lanyasunya): Thank you hon. Speaker. On behalf of the Budget and Appropriation Committee, I take this opportunity to table the budget report on estimates of the revenue and expenditure for the financial year 2016/17. Allow me to read the preface:

The constitution has placed significant responsibilities on county assemblies over the management of public resources. Section 131 (2) of the Public Finance Management Act, 2012, contemplates over the Budget and Appropriation Committee to oversight the budget process.

In this regard, Standing Order 187 establishes the Budget and Appropriation Committee with specific mandates among which is to:

- 1. Investigate, inquire into and report on all matters that relate to coordination, control and monitoring of the county budget.
- 2. Discuss and review the estimates and make recommendations to the house.

In line with the PFM Act section 129, the Constitution of Kenya article 221, the budget estimates and related documents for the Samburu County Government was submitted to the County Assembly on 29th April, 2016 and tabled on 3rd May, 2016.

When submitting the budget estimates, the PFM act section 131 requires the executive to attach:

- 1. A summary of budget policies including revenue expenditure, debt and deficit to financing.
- 2. An explanation of how the budget relates with the fiscal responsibility principles and the financial objectives.
- 3. A memorandum by the CEC for Finance explaining how the resolutions adopted by the county assembly on budget estimates have taken into account.
