## **PROCEDURAL MOTION- LIMITATION OF DEBATE ON BILLS**

### **SPONSORED BY PARTIES OR COMMITTEES**

**MCA Loosuk Ward,** (Hon. Kaunda Lenamparasio): Thank you Hon. Speaker. I beg to move the following Motion, THAT, notwithstanding the provisions of Standing Order 100 (4), this House orders that, each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of forty five minutes for the Mover, in moving and fifteen minutes in replying, a maximum of thirty minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes each (if the Bill is not sponsored by either of them); and that

priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.

I now call Hon. Stacy Nareyo to second the Motion.

**Specially Elected MCA**, (Hon. Stacy Nareyo): Thank you Hon. Speaker, I second the Motion.

**The Deputy Speaker**, (Hon. Jackson Lelenkeju): Hon. Members, I now propose the Question, **THAT**, notwithstanding the provisions of Standing Order 100 (4), this House orders that, each speech in a debate on Bills sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of forty five minutes for the Mover, in moving and fifteen minutes in replying, a maximum of thirty minutes for the Chairperson of the relevant Committee (if the Bill is not sponsored by the relevant Committee), and a maximum of ten minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes each (if the Bill is not sponsored by either of them); and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.

**MCA Nachola Ward**, (Hon. Lawrence Lorunyei): Thank you Mr. Speaker. From the start, I support the Motion, but Mr. Speaker, we need to be given this information on the County Assembly website so that we go through, and then when we come here every Member is satisfied than giving us when we are seated down. Now, it means we are just rubber stumping although it is a procedure. I beg that we be given, we go through and we are comfortable passing it at this stage. Thank you Mr. Speaker.

**Specially Elected MCA**, (Hon. Osman Dube): Asante sana Mheshimiwa Spika. Mheshimiwa Spika, ninaunga mkono. ### **PROCEDURAL MOTION -LIMITATION OF DEBATE ON INDIVIDUAL MEMBERS' BILLS**

**MCA Loosuk Ward**, (Hon. Kaunda Lenamparasio): Hon. Speaker, I beg to move the following Motion, **THAT**, notwithstanding the provisions of Standing Order 100 (4), this House orders that, each speech in a debate on Bills NOT sponsored by a Committee, the Leader of the Majority Party or the Leader of the Minority Party be limited as follows:- A maximum of three hours and thirty minutes, with not more than thirty minutes for the Mover, in moving and ten minutes in replying, a maximum of thirty minutes for the Chairperson of the relevant Committee and a maximum of ten minutes for any other Member speaking, except the Leader of the Majority Party and the Leader of the Minority Party, who shall be limited to a maximum of fifteen Minutes each; and that priority in speaking be accorded to the Leader of the Majority Party, the Leader of the Minority Party and the Chairperson of the relevant Departmental Committee, in that order.

I now call Hon. David Lekuchula to second the Motion.

**MCA Lodokejek Ward**, (Hon. David Lekuchula): Hon. Speaker, I stand to second the Motion.

**The Deputy Speaker (Hon. Jackson Lelenkeju)**: Hon. Members I now propose that notwithstanding the provisions of Standing Order 100/4 this House Orders that each speech in a debate on each Bill not sponsored by a Committee, the Leader of Majority Party or the Leader of Minority Party be limited as follows, a maximum of three hours and thirty minutes and not more than thirty minutes for a mover in moving and 10 minutes in replying. A maximum of 30 minutes for a Chairperson of the relevant Committee and a maximum of 10 minutes for any other Member speaking except the Leader of Majority Party and the Leader of Minority Party who

shall be limited to a maximum of 15 minutes each and the priority and priority in speaking be accorded to the Leader of Majority Party and Minority Party and the Chairperson of the relevant departmental Committee in that order. I now invite contributions from the Members. Silence means no contributions.

I now proceed and put the question that notwithstanding the provisions of Standing Order 100/4 this House Orders that each speech in a debate on Bills not sponsored by a Committee, the Leader of Majority Party or the Leader of Minority Party, be limited as follows, a maximum of three hours and thirty minutes with not more than thirty minutes for the mover in moving and 10 minutes in replying. A maximum of 30 minutes for a Chairperson of the relevant Committee and a maximum of 10 minutes for any other Member except the Leader of Majority Party and the Leader of Minority Party who shall be limited to a maximum of 15 minutes each and the priority and priority in speaking be accorded to the Leader of Majority Party and Minority Party and the Chairperson of the relevant departmental Committee in that order.

I beg to move the following Motion; that notwithstanding the provisions of Standing Order 100/4 this House Orders that each speech in a debate on any Motion including special Motion be limited in the following manner, a maximum of three hours and not more than 20 minutes for the mover and 10 minutes for each other Member speaking except the Leader of Majority Party and the Leader of Minority Party who shall be limited to a maximum of 15 minutes each and 10 minutes before the expiry of the time the Mover shall be called upon and the priority in speaking be accorded to the Leader of the Majority Party, the Leader of minority Party and the Chairperson of the relevant Departmental Committee in that order. I call hon. Silapia to second the Motion.

**The Deputy Speaker,** (hon. Jackson Lelenkeju): Hon. Members I now propose that notwithstanding the Provisions of Standing Order 100(4) this House Orders that each speech in a debate on any Motion including special Motion be limited in the following manner, a maximum of three hours with not more than 20 minutes for the mover and 10 minutes for each other Member speaking except the Leader of Majority Party and the Leader of Minority Party who shall be limited to a maximum of 15 minutes each and 10 minutes before the expiry of the time the Mover shall be called upon to reply and the priority in speaking be accorded to the Leader of the Majority Party, the Leader of minority Party and the Chairperson of the relevant Departmental Committee in that order.

the Leader of the Majority Party and the Leader of minority Party in that order. I now call hon. Lawrence Lorunyei to second the Motion.

**The Deputy Speaker**, (hon. Jackson Lelenkeju): Hon. Members I now propose the question that notwithstanding the Provisions of Standing Order 100(4), this House Orders that each speech in a debate on reports on Committees or any other reports submitted to the House for which the limitation of time has not been specified be limited as follows, a maximum of 60 minutes for the Mover in moving and 30 minutes in replying and a maximum of 10 minutes on any other Member speaking except the Leader of the Majority Party and the Leader of Minority Party who shall be limited to a maximum of 15 minutes each priority in speaking be accorded to the Leader of the Majority Party and the Leader of minority Party in that order.

**The Deputy Speaker**, (hon. Jackson Lelenkeju): Hon.
