Governor, His Excellency Lati Lelelit nominated and submitted the name of the nominee for position of Chief Officer for Vetting and approval by the County Assembly in respective dockets through the office of the Clerk vied a letter dated 7th June 2023, Ref: CGS/CA/APPTCO/VOL2/008/23.

On the 22nd June, 2023 and in the accordance with the Provisions of Section 7(1) of the Public Appointments County Assembly's approval Act 2017, the Speaker reported the receipt of the notification of the County Assembly the nomination of the County Chief Officer in accordance with article 185 of the Constitution of Kenya read with Section 8 of the County Government Act 2012 and Pursuant to the County Assembly of Samburu Standing Order number 46, the name of the nominee was referred to relevant Sectoral Committee for Vetting and reporting to the House within 14 days.

CONSEQUENTLY, in accordance with Section 7(4) of the Public Appointments, County Assembly Approvals Act 2017, the Clerk of the County Assembly placed a public notice on 22nd June, 2023 inviting the public to submit memoranda by way of written statements on oath and affidavits on the suitability or otherwise of the nominee in accordance with the Public Appointments County Assembly's Approval Act 2017.

The public notice indicated that submissions were to be received by 28th June 2023 by closure of submission period. The Committee did not receive any memoranda touching on the suitability or otherwise of the nominee. The nominee appeared before the Committee as scheduled Thursday 29th June 2023 for committee vetting in accordance with the provisions of the constitution County Assembly Act 2012 public appointment County Assemblies Approval Act 2017 and County Assembly of Samburu Standing Orders his suitability or otherwise for appointment to the position of Chief Officer.

Pursuant to section 7 clause 8 and 9 and section 8 of public appointment County Assemblies approval Act 2017 the committee observed that the nominee Mr. Lesilele Lysson met the integrity threshold, demonstrated knowledge of topical administrative and technical issues touching on the position of the Chief Officer for education and had requisite abilities, academic qualifications and professional experience to be approved for appointment as County Chief Officer in accordance with Section 45 Clause 1A and B, for the County Government Act 2012.

Having conducted the approval hearings for the nominee in accordance with the constitution County Assembly Act 2012 public appointment County Assemblies Approval Act 2017 and

Government act 2012 and section 126 of the public management act 2012 this plan is a key instrument in the budget making process as it lays down the county development priorities and forms the basis for resource allocation and spending in the County for the next five years the plan has been linked with National development plans such as Kenya vision 2030 medium term plans and the national special plan among other policy documents this linkage will ensure effective use of resources and building efficient in achievement of the Kenya vision 2030 objective.

Mr. Speaker, the Samburu CIDP (County Integrated Development Project) is the third plan to be prepared in Samburu County Government since the inception of the Constitution of Kenya 2010. The plan aims to achieve socio-economic transformation in the next five years. This will be realized through; investment in key sectors of Water, Agriculture and Infrastructure, Health, Education, Trade, Industrialization, Youth empowerment among others.

The plan will offer the County a chance to reach investors both locally and internationally to venture into a rich wide and vast area of investments opportunities and help the County to implement the many flagships' projects outlined. The successful implementation of the CIDP and its annual ADPs (Annual Development Plan) is estimated to cost KShs.39.6 billion out of which Kshs.32.2 billion will be funded internally and 7.3 billion is expected to be mobilized from development partners over the next five years. This is pecked on vibrant and innovative resource mobilization strategies. The CIDP becomes the County's contract with the people of Samburu to run the affairs of the County for the next five years.

Mr. Speaker, the County Government Act and Public Finance Management Act 2012, has placed significant responsibilities on the County Assemblies as related to Financial Management in particular regarding resource mobilization, planning, allocation, monitoring and evaluation.

The Committee Mandate and Legal Framework

Mr. Speaker, the Committee on Finance, Economic Planning and ICT is constituted pursuant to the provision of Standing Order 187 which states that: *There shall be a select Committee to be known as the County Finance, Economic Planning and ICT Committee. The Committee shall constitute of the Chairperson and not more than six other members. The function of the committee shall be to:*

- *i.* Investigate, enquire into and report on all matters related to coordination, control and monitoring of the County Budget.
- *ii.* Discuss and review the Annual Development Plans and make recommendation to the County Assembly.
- *iii.* Examine the County Fiscal Strategy Paper presented to the County Assembly.
- *iv.* Examine bills related to the County finance, including finance bills and evaluate tax estimates, economic and budgetary policies and programme with direct planning and finance out list.

The examination of the County Integrated Development Plan (CIDP), 2023/2027. Mr. Speaker as required by the County Government Act 2012, the Integrated Development Plan, was tabled in County Assembly and was committed to the Finance, Economic Planning and ICT Committee where it was examined and discussed.

Therefore, the Finance, Economic Planning and ICT held a public participation exercise on 3rd June, 2023 in various sub-counties in the County. The views of the public have been captured in this report. The Committee also held discussions with the Members of the County Assembly representing various Wards before finalizing this report. The recommendations arising from each of these discussions are contained in this report.

Mr. Speaker, once approved by the House, the CIDP will form the basis of the preparation on County Annual Development Plan for the next five years which will form budget preparation as required by Section 113 of the County Government Act.

Mr. Speaker, the Committee is generally indebted to all stakeholders without whose invaluable input the production of this report would not have been a success, in particular and with profound humility I wish to express utmost gratitude to the Members of this Honorable Committee, Members representing County Assembly Wards, all Honorable Members, the general public and all stakeholders who attended the Committee sittings and or public forum for this thoughtful engagement and commitment in the consideration of this County Integrated Development Plan(CIDP) 2023/2027.

Further, the Committee specifically thanks the Office of the Speaker and the Clerk of the County Assembly for lending the material and logistic support to the Committee which has resulted in the production of this report, in the same breath and with appreciation, I on behalf of the Members wish to categorically acknowledge the technical and professional support from the Committee secretariat and the partners, United States Agency for International Development (USAID) NAWIRI.

Mr. Speaker, it is therefore my pleasant undertaking on behalf of the Budget and Appropriation Committee to table this report and recommend the House for adoption. Mr. Speaker, the County Integrated Plan is a development blueprint for the County in the next five years, this plan forms the basis for resources allocation and spending in the County and no public funds shall be appropriated outside this planning framework developed by the County Executive Committee and approved by the County Assembly. The CIDP sets out broad strategy priorities and policy

goals that will guide the County Government of Samburu in preparing their Budget in the next five years.

Mr. Speaker, the CIDP shall be implemented annually through the Annual Development Plans that will give priorities, objectives and performance targets set by the County. This Annual Development Plan shall inform the County's Budget for each year. The CIDP will also be used to prepare action plan for the implementation of the strategies identified by the County. Adherence to the legal framework for the County Integrated Plan.

Mr. Speaker, the format and content of the CIDP plan should be in line with provisions of the various relevant legal instruments such as the County Government Act 2012, Public Finance Management Act 2012 among other policy documents.

In review, the CIDP the Committee established that; to a large extent the CIDP 2023/2027 has complied with the provision of the law and has provided most of the required information.

Analysis of the County Integrated Development Plan (CIDP).

Departmental Projects

Mr. Speaker, the law requires that the County should only allocate funds and implement programs and projects that have been factored in the CIDP 2023/2027. Mr. Speaker the Committee noted that some Departments had stalled projects, the Committee recommends that those projects should be assessed and completed to avoid loss of public funds. On the ongoing projects, multi-year projects they were concerned on the slow paced on completion of ongoing projects. The Committee noted that, departments lack plans and projection on the actual cost of the project and the timeframe required for its implementation, this delay increases the cost of the projects. In the future, the Executive is urged to do proper planning before embarking on the multi-year project.

Mr. Speaker, most Departments provided resource summary for each Ward, it was noted that, there is skewed resource allocation across the Wards. The County Executive is therefore required to develop a policy on how resources would be allocated in Wards.

Recommendations of the Committee

Mr. Speaker, the Committee urges this House to adapt this report and resolve the following;

- I. The County Assembly adopts all the ongoing projects in the County Integrated Development Plans as proposed by the County Executive.
- II. The County Assembly programs and projects as captured under priority interventions be part of the County Integrated Development Plans 2023/2027.
- III. The new programs and projects as listed under priorities intervention be part of the County Integrated Development Plans 2023/2027.
- IV. The programs and projects proposed by the public be incorporated in the CIDP.
- V. The Committee recommends that those projects that has been stalled to be accessed and completed to avoid loss of public funds and the ongoing projects, multi-year projects. The Committee was concerned on the slow paced of the completion of the projects.

Asha Mohammed): Thank you Mr. Speaker I would like to thank the Committee for the commendable job you have done including myself we went round and also we collected views of our people there are some sub Counties that we went through and see some projects that are not even important but the committee captured all of them and also some paces which we need revenue offices revenue clerks like Nachola and also Archers another thing I would like to thank our PACIDA for allowing us to go around and also the County Assembly

and also what we have captured in this I would like to ask the Hon. Members kindly lets support this thing and pass it thank you.

MCA Nyiro Ward, (Hon. Jonathan Lemoosa): Thank you Mr. Speaker much as I support the report on CIDP but there are few Areas actually which needs to be noted because this is a five year plan and actually if we miss a point it becomes hard to finance projects which actually needs to be funded for example as we were walking as we were indulging and interrogating the public on budgeting there is this area called Malaso, Malaso actually has a view point and it's a place which needs to have a few revenue offices such that we don't miss the revenue so this is very important to note before we conclude much as we support two there are areas which were proposed and I think because of either typing or something there is some omission like Loruko in Nyiro.

Most of the Members who Have visited Nyiro Loruko actually is a center which is in the middle of nowhere because they need a dispensary because it is actually 16 km from South Horr 30 km to Baragoi and 15km to Waso Rongai so this center we proposed to be part of government funding in the subsequent funding of the CIDP there is also areas like Tuum and Wasorongai slaughter houses and there is no revenue but you see but there are no revenue clerks meaning the County Government is losing this are some of the loop holes we are saying if we could tighten then we abound to increase our revenue collection.

Therefore, wish the clerks and the committee to consider this after we have passed as part of our additional revenue sources and maybe some services otherwise I wish to commend committee in its superb piece of work and the office of the Speaker and the clerk and our partners so thank you Mr. Speaker.

Specially Elected MCA (Hon. Silapia Lenamatiyo): Thank you Mr. Speaker for giving me another chance to share my concern Mr. Speaker when we talk about the CIDP, CIDP is a plan a 5yr plan M r Speaker it's very important and it's so prudent when we make a CIDP just to put on the shelves of the executive and also to county assembly and not going to be implemented.
