### **STATEMENTS.**

I seek for your guidance because every statement needs to be tracked and any business to be transacted in this House must be approved and then be in the order paper. Hon. Speaker we need your guidance because the Members are not guided and because their statements are not on the order paper and there is no any tracking, so, we seek for your guidance Hon. Speaker.

**Specially Elected MCA,** (Hon. Lenamatiyio Silapia): Thank you Hon. Speaker. I think it is not a crime for me to remind the House on the same matter and I think we need some seriousness in this House that when we request for statements we are supposed to wait for the response. I remember the day the Hon. Speaker ruled that the Committee to write a letter to the concerned authority to appear before the Committee but it seems that nothing is being done and I do not know where there are loopholes, but form me it was just a reminder.

I have nothing bad on this. But even our Standing Order guide that without indicating on the order paper, we cannot ask statement or reminding on the statement, thank you Hon. Speaker.
